DR. PATTON HONORED BY HOME STATE

Dr. Wendell M. Patton, President of High Point College, was among those honored by the South Carolina Homecoming Committee on Hilton Head Island in November, 1966. Honorary chairman for the event was James J. Byrnes, Govenor of the State of South Carolina.

John Gettys Smith, chairman of the South Carolina Homecoming Committee, expressed the purpose for the recognition in his letter of invitation by stating: "We feel that our state, with a comparatively small population, has perhaps produced a disproportionate share of outstanding people."

Dr. Patton is one of the 135 native South Carolinians who have distinguished themselves in various fields and who no longer reside within the state. Nationally recognized South Carolinians who are leaders in education, church, military, business, finance, arts, science, and government fields were honored.

## EARLY BASKETBALL NEWS FOR THE ALUMNI

As the 1966-67 basketball campaign gets underway, the High Point College Purple Panthers have already displayed enough power and awesome strength to give fair warning to the rest of the league that they are hungry for another taste of the championship berth.

With only five games under their belts, at this writing, the Panthers are once again undefeated and off to another whirlwind start.

The Panthers, sporting one of the league's most effective offenses, are currently averaging 92.6 points per game. They have broken the "hundred barrier" once this year while holding the opposition to an average of 78.0 points a game.

Coach Bob Vaughn, the Panthers' new coach from Surrattsville, Maryland, inherited an ideal team when he accepted the position, but along with it came pressure to equal or surpass the performance of the prior "Tom Quinn Squads." Despite this pressure, Coach Vaughn has whipped the Panthers into one of the best clubs that H. P. C. has ever sponsored on the hardwood.

The 1966-67 edition of the "lizards," a nickname used jealously by fans of the opposition, features the sensational 3rd Team Little All-American guard, Eugene Littles. At present, Littles is averaging over 30 points a game and has continued to spark the club with his clutch shooting and floor generalship.

Another pleasant surprise to Coach Vaugh has been the great improvement of sophomore center, Jim Picka. The 6' 11" giant has dominated the backboards and poured in a total of 81 points for a 16.2 average. Coach Vaughn says of Picka, "Jim has come along real well for us- I think his improvement over last year stems from the fact that he is older and is able to move much better under the boards."

John Davis, a top-notch defensive player, has just begun to reach his scoring capacity. In the Campbell game, John scored 26 points and played a vicious board game.

Pepper-pot guard Chris Lindsay has improved this year. Off to a slow start because of frequent foul trouble, Chris has begun to bomb points in from 30 feet while combining with Littles to spearhead the Panthers' fast-break offense.

Even though the Panthers have four sophomores in the starting lineup, the value of senior Co-captain Bill McDermott cannot be overlooked. Bill's team leadership and experience, to say nothing of his brute strength as one of the club's top rebounders, has given him the "father image." "Uncle Billy" played the best game of his career recently when he scored 18 points with almost as many rebounds.

The top reserve has been freshman Danny Witt a High School All-American from Baltimore, Md. Witt came off the bench in the first game of the season, and his first game as a college player, to lead the Panthers in scoring with 22 points.

Larry Wall, hampered by an early season foot injury, and Ron Loewenthal are the two junior reserves who give the Panther bench considerable strength which was lacking in last year's squad.

Senior Jim Spiridopoulos and freshman Steve Matthieson have also seen action this year as they round out the small ten-man squad of the Purple Panthers.

The future looks bright for the remainder of the season as the Panthers use their superior height and game savvy to stage their drive for the carolinas Conference Championship in February.



## High Point Resource Area Organizes For Action

Chairman, Ed Mendenhall, met with his four Majors, Chairman, Bill Henderson, W. Lawson Allen, and Dr. Carl Savage on January 16 to make plans for enlisting workers to present the College needs to individuals and businesses in High Point. The four majors are: J. Roscoe Adams. Wachovia Bank and Trust Company; Fred Alexander, President of High Point Bank and Trust Company; J. Ed Pleasants, North Carolina National Bank; and Dick Edmundson, Manager of Sears new store.

At a meeting at High Point College on February 13 at 4:30 p.m., Chairman Mendenhall asked W. Lawson Allen, Director of Public Affairs, to present the procedure for the High Point Business Resource Area. Seventeen Captains have accepted the responsibility of securing four workers who will in turn select the names of four firms or individuals in High Point to which to present the

needs of the College.

The calendar as presented by Allen sets the date of February 27 as the deadline to obtain the additional workers. March 6, was selected as the date for the kickoff meeting and training session for all workers. The names of those to be contacted will be selected by the workers themselves. March 20, was announced as the first report meeting for all workers.

The list of the seventeen Captains affords an outstanding group of community leaders: Dick Culler, Jr., Vince Spracklin, Mrs. W. T. Powell, Fred Council, Dr. I. Paul Ingle, Douglas Kerr, Jim Burnley, Bill Hylton, Ted Pettyjohn, Wilbur Groome, Dean Rich, Herman Bernard, C. Louis Huff, Sanders Dallas, Jr., R. E. Clement, Carter Holbrook, and Bill Ervin. Each one of these Captains has accepted the responsibility with enthusiasm.

## Golden Decade Board of Advisers Meet At College

The Board of Advisers of the Golden Decade Development Program met on Monday afternoon, February 13, 4:30 p.m., in Roberts Hall on the campus. The first meeting of this Board was an outgrowth of the November 4, Development Conference. Nearly 100 outstanding men and women in ten resource areas attended the November 4 meeting and made suggestions and recommendations for the future of High Point College.

The Golden Decade Development Board of Advisers is composed of the chairmen of the resource areas and a like number of members selected at large. Outstanding men and women from across the state have accepted membership on the Board. These individuals have agreed to become members in order to use their influence and advise the trustees and administration in matters of development and advancement in the 10-year program to secure \$10 million to undergird the College on its long-range plans.

The Chairman of the Golden Decade Development Board of Advisers, Mr. W. R. Henderson, is President of Bennett Advertising, Incorporated. Resource Area Chairmen are: Roger Soles, President of Jefferson Standard Life Insurance Company; Ed Mendenhall, President of Mendenhall-Moore Realtors; Vincent Spracklin, Trust Officer of Wachovia Bank and Trust Company; William McGuinn, Public Relations Officer, High Point Bank and Trust Company; Charles E. Hayworth, President of Alma Desk Company; Dr. Phil Shore. District Superintendent of the High Point District of the Western North Carolina Conference of the Methodist Church; Dr. Larry B. Holt, eye surgeon: Holt McPherson, Editor of High Point Enterprise; and Dr. Wendell M. Patton, President of High Point College.

Others who have accepted membership on the Board are: Mayor Robert L. Reese of Asheboro; Mayor Stanford R. Brookshire of Charlotte; Governor Dan K. Moore; and Dale Montgomery, Chairman of Guilford County Commissioners.

The meeting on February 13, was directed by Mr. W. R. Henderson. Reports were given by chairmen of the various resource areas. An interesting report was given by the Corporate Partners Resource Area with 20 corporations indicating that they would share their profits with the College. The High Point Business Resource Area reported that the organization was being built to solicit individuals and businesses in High Point.

## Trustees Of Methodist Colleges Of N. C. Invited To Conference

High Point College will provide another service which will give the College an additional rung in its ladder of leadership. On April 28 and 29 the Trustees Conference will bring to High Point outstanding men to present views and trends in trusteemanship. Dr. J. L. Zwingle, Executive Vice President, Association of Governing Boards of Universities and Colleges, Washington, D. C., will be among the program personalities.

Dr. Ralph Decker, Director of Department of Educational Institutions, Division of Higher Education of the Board of Education of the Methodist Church, Nashville, Tennessee, will appear on the program both on Friday and Saturday. Dr. James W. Fowler, head of the Western North Carolinas Conference, College Coordinating Council, will be present to share in the program. Former Governor Terry Sanford, trustee of Methodist College and former Chaiman of the Board of Trustees of the University of North Carolina will bring the closing address at lunch on Saturday the 29th.


Trustees have been informed of the Conference and asked to clear the date for participation in the sessions beginning at 4:30 p.m., on the 28th at the Sheraton Hotel. An invitation went out on February 20 to the trustees of Brevard, Pfeiffer, Greensboro, Louisburg, Methodist, North Carolina Wesleyan, and High Point Colleges.

#### PLANS FOR INFIRMARY REVISED

Revised tentative plans for an infirmary have been received from the architect according to Earle G. Dalbey, Business Manager of the College. Dalbey states, "These plans may not incorporate all that is wanted, but at least, they are more nearly in line with the funds which are available with which to construct the building."

The revised plans have more than 3,300 square feet of floor space and make provision for any illness short of epidemic proportions. The building is so designed that it is possible to have twentyfour hour nursing service if feasible.

Funds have been designated by Mr. A. A. Shuford, Jr., of Shuford Mills for the erection of the imfirmary. Some of the 30 doctors who have attended High Point College have indicated an interest in the infirmary. Ten dentists have graduated from the College, also.



## Grant For Lecture Centure Approved College Seeks Additional Funds

A grant for \$82,333 has been approved by the Department of Health, Education and Welfare, according to a release by Chalmers G. Norris, Chief of College Facilities Branch of the Department. This grant is one-third of the estimated cost of this facility which consists of two lecture rooms with capacity of 250 and 100 with stage, latest equipment for visual aids, seminar rooms, large hall for receptions, kitchen, 2 rest rooms, and faculty offices.

According to Dr. Wendell M. Patton, the trustees have not indicated when construction will begin due to the lack of \$166,677 which the College will have to put up to assure construction.

The Lecture Center would be used for large multi-section courses such as the history lectures now held in the Memorial Auditorium. Many of the activities now held in the foyer of the auditorium could be held in the large hall. The small group cultural activities of High Point could be scheduled here, such as plays, concerts, lectures, and the like.

The architect, Leon Schute, is working with Earle Dalbey, Business Manager to make changes and secure tentative plans for the building. The College is seeking a donor that is willing to give \$100,000 toward this building which could bear the name of the donor, or someone he wishes to memorialize.

#### HIGH POINT COLLEGE LOOKS TO THE FUTURE

In his will James B. Duke, selected Duke University. "I have selected Duke University as one of the principal objects of this trust because I recognize that education. . . is, next to religion, the greatest civilizing influence."

Bequests have never been a large factor in the support of High Point College, but as the College moves through the years, it must continually progress, develop its facilities, it faculty, increase its excellence and its potential to serve.

Bequests must become an integral part of means which are necessary to meet the needs of each succeeding student generation. In the last few years, there have been an increasing number of individuals who have, in the planning of their estates, remembered High Point College and its needs. Alumni, trustees, faculty members and other friends have been thoughtful and gracious to include the College in their wills.

It has long been the policy of our government to encourage, through estate tax laws, giving to educational and charitable institutions. It is frequently possible, by thoughtful planning, to give generously to High Point College at a small cost to the individual or his estate. It is advisable always to seek legal counsel when making deferred gifts.

Bequests may be for an established amount, for a percentage of an estate, or for real property or other assets. Bequests may be large or small, with each expressing the donors' ideals and hope. They may be made in the body of a will or as a codicil to it.

Gifts by trust are of many types and can be established for the common benefit of the donor and High Point College. One example is a trust which may yield its income to the donor or someone he names with the principal ultimately going to the College. A trust may be either irrevocable or revocable with tax advantages varying with the type of trust established.

Participation in the Estate Planning Program will have an important effect on the future of High Point College. Some have made bequests and have notified the College, others have not. The Estate Planning Committee of the Golden Decade Development Program has been selected to help the College in the areas indicated.

Mr. Vincent Sparacklin, Trust Officer of Wachovia Bank and Trust Company of High Point is Chairman of the committee and Mr. Perry Keziah is Co-Chairman with him.

By making High Point one of your beneficiaries and then permitting the Committee to list your name with the names of other participants, you do High Point College a double service. You give promise of needed support and you encourage by your own act a similar response by others.

High Point College needs well-qualified students if it is to continue as a quality institution. You can assist your alma mater by recommending that good students apply for early admission to H.P.C. The S.A.T. scores of students admitted to High Point College for the Fall Semester, 1966, were above the national average. On February 18, your Executive Committee passed the following resolution: "The Executive Committee recommends that the Alumni Association of High Point College support two tax relief bills that are in the N.C. The second tax relief bill provides \$300 additional dependents allowance for support." (N.C.H.R. Bill No. 32 and N.C. Senate Bill No. 18)

Many additional young men and women will be better able to attend college by having the financial relief provided for by these tax relief bills. In addition, an individual who has attended college usually pays more taxes than a person who has not attended college. Therefore, the passage of the tax relief bills should ultimately bring additional revenue into our state.

You can assist parents in securing a \$900 yearly deduction for dependent college students by contacting your representative and senator in the N. C. Legislature.

## WE WILL PROVIDE HIGHER EDUCATION FACILITIES

One way or another the youth of our state will have the opportunity to get a college education. In 1868 the Constitution of North Carolina affirmed that the privilege of education is the citizen's birth-right and sets forth the State's obligation to maintain that right and encourage its fulfillment. Historically, higher education has been a major factor in the establishment of North Carolina's reputation as a progressive state.

Higher education in America is a product of the Church. From Harvard for more than 150 years until the University of North Carolina opened its doors in 1795, independent and church-related higher education held sway. Davidson College, then Wake Forest were opened before the mid-19th century. Until the 20th century was well along the majority of college students were enrolled in private schools. Such is not the case today. Last fall (1966) the enrollment of tax supported institutions of higher learning in North Carolina had 59% of all students. The increase is nearly 2% each year in favor of the tax supported institutions.

#### The North Carolina Position

Our high school graduates are going to college. Where they go is largely a matter of economics. With the rise of the Community College, within the foreseeable future every high school graduate can be enrolled in an institution of higher learning.

The student who attends a tax supported institution in North Carolina pays on the average \$891 per year for room, board, and fees. The State appropriated another \$1030 last year for each student attending a tax supported college whether as day or boarding student. The stu-

dents who attend private colleges saved the taxpayers of North Carolina the sum of \$47,112,000 last year!

A very cursory glance at these facts indicate that with the ever increasing number of high school graduates attending college, it is to the great benefit of the taxpayers to see to it that the private colleges continue to grow and de velop. The taxpayer will pay one way or the other - voluntarily through the private college or involuntarily through taxes to meet increasing expenses at the public institutions.

### What Will Happen To The Private College?

Does the private colleges have a case? The history of independent higher education attests to the fact that it does. Liberal arts education it has been said offers the last bulwark for free enterprise. The private college provides freedom from political chicanery and protects the academic freedom not only of the private-independent college, but also the public institutions.

If the taxpayer wishes to assume the 41% in addition to the 59% now being supported, which is 75% increase in taxpayers funds for higher education, the way is now being cleared. The State will extract the funds in taxes and in addition will ask you to provide voluntarily funds for additional staff members, facilities and endowment. More and more this is the case.

The taxpayer will pay one way or the othereither in taxes to support public institutions or in gifts to undergird and make strong the private, church-related, independent colleges.

We will pay! We will provide for the education of our youth. Which approach shall we take? We must do both.



The Horace S. Haworth Hall of Science Nears Completion

The new science building was named the Horace S. Haworth Hall of Science by the unanimous action of the Board of Trustees to honor, a long-time trustee, faithful servant, and respected attorney of High Point.

The Science Hall is nearing completion, as far as construction is concerned. The parking lots are being prepared for paving. The furnishings will arrive late which will necessitate moving the old furnishings from the present science building during the summer with the hope that new equipment will arrive by August 15, so that it may be installed by the opening of the fall semester.



## High Point Closes Follow-up Campaign, April 5

The High Point area follow-up of the 1st phase of the Golden Decade Program of Development was organized under the leadership of Ed Mendenhall, President of Mendenhall-Moore Realty Company. Four Majors were enlisted: Roscoe Adams, Wachovia Bank and Trust Company, Ed Pleasants, North Carolina National Bank, Fred Alexander, High Point Bank and Trust Company and Dick Edmondson, manager Sears Roebuck and Company.

Each of the Majors selected at least four Captains. The organization was complete with a total of seventeen, who in turn selected and enlisted four lieutenants who accepted, on March 7, prospects to contact in behalf of High Point College.

The First report period was held on March 20 with about one-third of the workers reporting. The closing date was April 5th. While it is too early to ascertain the total received, the contacts were fruitful.

More than 250 prospects were seen during the four weeks effort. The organization was as efficient as any that we have observed with almost 100% effort to see prospects. The Majors were always cooperative. The Captains were ever at the task of seeing that lieutenants were making an effort to solicit the prospects.

The High Point follow-up effort will give impetus to the entire development program. A hearty "thank you" is in order to all who were involved.

## The Trust Offers Special Opportunity For Charitable Giving

A trust is an arrangement whereby property is held by a Trust Company, other institutions, or individuals for the benefit of others. There are several kinds of trusts.

1. The Living Trust is a Trust created during the lifetime of the person or persons setting it up.

2. The Testamentary Trust is a trust created by will.

3. An Irrevocable Trust is one which cannot be ended by the person creating it.

4. A Revocable Trust is one which may be ended by the creator.

The Trustee may be a company or individual holding the trust property for the benefit of others.

Trusts may be set up to avoid payment of income taxes on a given investment or portfolio over a period of not less than two years. The arrangement is very helpful for the person who is in a high tax bracket now, but will need the principal at a later date (after two years). In addition, there may be decided advantages in estate planning.

The trust is often used to care for wife or children as well as offering a very effective and satisfying method of charitable giving.

The first Conference for trustees of all North Carolina Methodist colleges has been planned for April 28-29 at the Sheraton Hotel in High Point sponsored by High Point College. The Conference is made possible by a grant from the Shell Companies Foundation, Inc.





DR. HINSHAW, FORMER DEAN, SUCCUMBS AT 77

Dr. Clifford R. Hinshaw, longtime teacher and administrator, died April 11 at the age of 77.

Dr. Hinshaw had been in the service of High Point College since 1927 when he became teacher of education and psychology. As Chairman of the Department of Education and Psychology, he was instrumental in getting state accreditation for the teacher education program.



## What Could High Point Do With \$10 Million?

We become confused by the announcements which come to our desks concerning Tulane's \$24 million far exceeded with more than \$27 in cash and pledges for the "Forward Fund." This includes a \$6 million Ford Foundation grant. There is Duke with its \$90 million goal over the next few years to stagger our imagination. Then comes Wake Forest University with long-range needs of \$100 million over the next ten years. We could go on to tell of Brandeis -\$14 million; Claremont College - \$39 million including matching grant of Ford Foundation, and others.

The \$10 million Golden Decade Development Fund goal seems small beside some of these, yet it must be realized if High Point College is to continue to grow and develop. What could we do with \$10 million? We could at this time proceed to build a student center; the dormitories; the administration building; the religious center; the library; and have enough endowment to bring in more than \$100 thousand additional revenue for the College. Indeed the \$10 million may seem small as compared with Duke or Wake Forest, but it would give High Point College financial stability for the next ten years.

What would be the results if from some source, High Point College would receive \$1 million? It would result in many others taking a good look at the College which someone thinks is worthy to receive and use \$1 million. It would engender new enthusiasm, for too long we have majored on the \$1 gift. Giving of this sort never has challenged others to give, nor has it enhanced

the financial position of the College.

As you read this article, will you stop, meditate, think and reflect on the possibility of a deeper commitment of life and material possessions to the service of the Master of Men? All the staff that could be acquired cannot raise funds to keep the College advancing. We must have the interest, influence, and work of friends from Alumni, from the Church, from the community of High Point, and from beyond.

What couldn't we do with \$1 million?

43rd Year With Optimism

High Point College on May 21 closed out another successful year - the 43rd - with the awarding of three honorary and 153 bachelor's degrees and ceremonies retiring three faculty members with a total of 85 years service to the College.

Honorary degrees were conferred on The Reverend Edgar Harrison Nease, Jr., minister of the First Methodist Church, High Point; The Reverend William Howard Miller, Jr., minister of Trinity Methodist Church, Durham; and to Mr. Archie K. Davis, Wachovia Bank and Trust Company, Winston-Salem.

Dr. Wendell M. Patton, President of High Point College presented diplomas to 153 men and women who received the A.B., B.S. and A.B.T. Degrees.

Three faculty members were honored by the trustees and administration of the College upon retirement from active duty as teachers. Dr. E. O. Cummings came to High Point in 1927 and closed out forty years of service as teacher of chemistry and head of the department. Miss Ernestine Fields professor of organ and piano was awarded a citation for 24 years of service. Dr. S. C. Deskins was honored not only for his years of service since 1948 at High Point College as professor of history, but for his long years of service to secondary education.

Most of its alumni are not wealthy (over 50% of its graduates become teachers); its support from the Methodist Church is not flexible. Pulling itself up by its bootstraps, this young College is seeking 'Profits Pledges' from any corporation whose officers believe in church-related higher



The Alumni Association takes this opportunity to thank all the alumni who made it possible for us to exceed our 34% participation goal for the 1966-67 fiscal year. ## Another Year's Work - Another Review of Results

The office of Public Affairs is a rather conglomerate and inclusive operation which includes development, fund-raising, public relations, information services, alumni affairs, photography, records, and mailing services. The office of public affairs takes the position that development includes the entire structure of college life-faculty, students, physical facilities, academic, social, church, and community life. It is the concept of this division that the entire College is our field. Without interfering in the internal affairs of any other department, we work to meet the needs that growth and progress demand.

## Golden Decade Shows Progress

Beginning with June, 1966, the Golden Decade Development Program assumed a role primarily of consolidation and collection of pledges made in the Golden Decade campaign of late 1965 and early 1966. The following gives an idea as to the first phase standing.

The total number of gifts for the year was 1,050. These gifts were made by 733 individuals

and 123 corporations for a total of 856. This means that 193 gifts were by those who had already made a gift. This duplication can be accounted for by those who gave monthly, quarterly, or semi-annually.

During the year a total of \$335,897.09 was given to the Golden Decade. These amounts do not include annual alumni loyalty and other funds except as pledged through the Golden Decade Program.

Other gifts, 63 in number, amounted to \$80,206.25. Three hundred six (306) gifts of \$100.00 or more were made to Golden Decade, June 1, 1966, thru May 31, 1967. Of the three hundred six (306), seventy-five (75) were alumni gifts.

#### Board Of Advisers Constituted

During June, July and August, the Golden Decade Development Board of Advisers, which was approved by the Trustees, was organized. This Board replaced the Development Council which has been set up prior to the Campaign. The list of members follows:

### Annual Development Conference Held

November 4, 1966, was the date of the Second Annual Golden Decade Development Conference. Invited were 242 outstanding men and women from across the State of North Carolina Of these invited participants, 109 responded by saying they would attend. When all were registered, there were only 88 present, but they were the kind of people which were wanted to become involved in the development of High Point College.

These were divided into 10 resource areas. Each area was headed by a chairman, a discussion leader, and a recorder. Questions of importance and bearing on the problems within the resource area and the College were prepared before the meeting.

The purpose of the Conference as stated was ... "to provide the Board of Trustees and the Administration of the College with the opinions and the recommendations of a carefully selected cross section of its constituency, relating to specific areas which are involved in College planning for both the present and the future."

Every area which had participants gave a report and these were edited, bound, and sent to each participant. A summary statement was included and later the recommendations of the group were presented to the Board of Trustees for action. At the close of the fiscal year no official action has been taken on the proposals. The next annual conferenc will be held on October 2, 1967.

## The High Point Business Resource Area Mounts A Campaign

Under the leadership of Ed Mendenhall the High Point Business Resourece Area workers met on March 7, 1967, at the Sheraton Hotel for the purposes of crowning Miss Golden Decade of 1967, training workers, and to kick off the campaign for funds for the Golden Decade in High Point among those prospects not seen in the campaign in 1965 and 1966. About 40 workers out of 64 were present and prospect cards were chosen from the boards arranged about the wall. The captains in some cases selected cards for their workers.

Miss Dianne Holt of Charlotte was crowned Miss Golden Decade of High Point College to succeed Sherri Snow.

The first report period was scheduled for March 20, 1967, at the Sheraton Hotel. The following report shows the organization and the results. While not impressive the value lies in the fact that about 80 individuals talked to more than 200 people about the College and its needs:

## Other Areas of Development Emphasized

On February 15, 1967, the Sears store opened on the Magic Block. The construction of a large warehouse on Kivett Drive was completed in December. Both the store and the warehouse were built without using any current funds or endowment. When the loan is paid off, this operation will be an asset to the endowment fund of the College. Until that time all revenues will be used for taxes, maintenance, interest and the payment of the loan.

### Science Building Named

The science building which is named for the vice-chairman of our trustees, Horace S. Haworth, is nearing completion and will be available on September 1, for the sciences and mathematics. Financed by a Federal Grant, a Federal Loan and Golden Decade Funds, this building is the best sceince facility in North Carolina's small colleges.

### Other Buildings Planned

The trustees have given tentative approval to go ahead with a dormitory for women to be ready for the fall of 1968. This dormitory will house 144 women with lounges, air conditioning, carpet, with suite arrangement. Another dormitory for men and a college union building have also been placed in the planning stages. The chapel-religious center is also being planned.

#### Dennis M. Cooke Building

The former science building has been named for former president Cooke, who is now head of the department of education and psychology. This building will be used for classrooms and faculty offices.

## ALUMNI ACTIVITIES EXPERIENCE BEST YEAR

Alumni Affairs under the direction of Executive Secretary, Miss Beverly Deal, showed gratifying progress during the year. When Miss Deal came to the office in October there were many activities to be planned.

### Annual Parents' Day Report

The Annual Parents' Day was open to all parents of students. The authorities were encouraged by the fact that of the 400 parents registered, 60% were parents of freshmen, 20% sophomores, 15% juniors and 5% seniors. The large percentage of parents of other than freshman seemed to indicate a need for this program.

#### Homecoming Was Held In February

A loyalty fund meeting for leadership of the Loyalty Fund Campaign and the Alumni Reception were undertaken by the alumni this year. Homes of alumni in High Point were opened to all reunion classees but two. At least 500 alumni were present for the day's activities.

Senior investiture day was observed with Luther Medlin of Greensboro as the guest speaker at the investiture assembly.

### Off Campus Activities Were Provided

Ten of the eleven alumni chapters held dinner meetings during the year. The secretary met with the other chapters and in addition met with a group of alumni from Asheville and vicinity. The annual spring meeting will be emphasized instead of trying to have three or four meetings a year.

## The Executive Committee Has Important Function

The men and women who make up the Executive Committee are loyal to the College and give much time and effort to create the guidelines for effective image building. Dr. Lawrence Holt, immediate past president has given of his time, money, and influence to create a better image of the College among the alumni themselves. He built on the solid foundation of those before him. Dr. Edwin Auman, the newly elected president will provide progressive leadership in alumni affairs.

## Alumni Giving Progress Is Encouraging

The following report shows the definite upward trend of alumni giving. With the exception of 1965-1966, every year since 1960 shows an increase over the previous year. The slump in 1965-66 can be explained by the emphasis on the Golden Decade and the late date of the beginning of personal solicitation due to the Golden Decade emphasis.

## THE COLLEGE INFORMATION SERVICES SHOWS PROGRESS

The annual report from Information Services as compiled by Mrs. Margaret Ingram gives statistical information concerning the activities in the News Bureau, Radio, and Television coverage. Dr. Carl Savage head of this department of

Public Affairs division gave many hours in preparation for airing of programs over 14 radio stations, a thirty minute, weekly television program over WGHP-TV, and in gathering and sending out the news about the College.

An average of one release each day sent to 76 newspapers, 32 radio stations, and 11 television stations, making a total exceeding 20 thousand individual releases, or more than 100 each day. As proof of the effectiveness, there were received from our clipping service within the state more than one thousand clippings, which amounts to four clippings for each release.

The use of photographic material was not overlooked. More than 400 pictures accompanied the releases. The photographic lab under Dr. Savage's direction produced 2 thousand pictures

for all purposes. The Golden Decade, The A-lumni and Development Bulletin, the Hi-Po, Catalogues, and the Zenith were all provided with pictures.



## The Third Annual Development Conference Is Held

The Third Annual Development Conference of the Golden Decade met at the Horace S. Haworth Hall of Science on the campus at High Point College, Monday afternoon, October 2, 1967 at four o'clock. Mr. William R. Henderson, chairman of the Golden Decade Development Board of Advisers, presided over the first session in the large lecture room. The 107 participants attending the conference were divided among the eleven resoure areas.

Each resource area had a chairman, a discussion leader, and a recorder. The resource areas were chosen to encompass the various interest and geographical Constituencies. The family group was divided into three areas: the faculty, the alumni, and the students. Normally the trutees would fall in this grouping, but in this conference they were used as resource people in other areas. The family as well as other resource

areas discussed several general questions along with those which concerned the particular group itself.

The High Point Community was represented by three interest groups: The High Point Business Resource Area, Clubs and Organizations, and the Corporations Areas. Other resource areas included were: Estate Planning, Out of Town, Public Relations, Foundations, and Church Relations.

After the first session the eleven groups were escorted by faculty, staff, or students to the assigned rooms for discussion sessions. This session began at 4:30 and was recessed for dinner at 5:15. The meal was served to all participants from the regular cafeteria line.

Immediately following dinner the discussion groups met for the second session. At 7:45 the summary session was held in the large lecture room.

## Development Conference Participants Make Suggestions

Many interesting and significant suggestions and recommendations were made at the closing session. To name a few:

- 1. That the next phase of the Golden Decade Development Program be set to begin in the Fall of 1968 and to be concluded in the winter of 1968-69.
- 2. That an adequately trained professional full-time staff member in the field of estate planning should be added at once to the development staff.
- 3. That the student-union building should be the next building constructed on the campus. This was closely followed by a men's dormitory.
- 4. That campus-community relations should be promoted by more groups being invited to the campus.
  - 5. That a board of visitors be formed.
- 6. That at least 25 additional CORPORATE PARTNERS should be added during the year.
- 7. That the faculty be invited to continue to participate in the Golden Decade.
- 8. That students be given an opportunity to help plan buildings and become a part of all the activities that are of interest to them.
- 9. That a better public relations program be an immediate goal of the College.
- 10. That a development conference meets a need in the development program and should be continued.

## Is "To Give Or Not To Give" A Reasonable Question?

The person who has accumulated properties which produce income, strange as it may seem, can by a program of gifts that is started during life produce advantages to the donor the person making the gift. For example, such gifts may actually increase the donor's spendable income and without having to pay a capital gains tax.

The key to such economic benefits lies in planned *charitable remainder* gifts or gifts under which the donor retains the income for life.

# TAX DEDUCTION FROM CHARITABLE GIFTS

When an individual gives property to a college but retains the income for life, he has made a gift of the remainder interest. Under current law, the donor is entitled to a federal income tax deduction of the present value of the remainder interest.

The present value of a charitable remainder and therefore the amount of federal income tax deduction depends on (1) the value of the property that is given and (2) the age of the donor at the time of the gift according to Internal Revenue Service tables.

# HOW TO INCREASE THE DONORS' SPENDABLE INCOME

Very often a gift of property which already provides income for the donor may with the income retained, produces extra spendable income in the year of the gift. This is true because the donor still receives all the income from the property given away - thus his year's income will be the same as before the gift was made. Therefore he will have more spendable income in the year of the gift because of the income tax deduction resulting by giving a remainder interest to the college. Spendable income may be increased up to 35% of the taxable income by the amount of the taxes he saves.

If the remainder gift is more than the 30% of the taxable income, the donor may make payments in installments over several years. Each installment is treated as a separate gift. The value of the charitable remainder portion of each gift depends on the donor's age at the time each installment is actually paid. At 60 years the value of the remainder interest is 60.321%; at age 70, 72.63%; 80, 83.241% of the total present value.

# TAX-FREE DIVERSIFICATION OF INVESTMENTS

A property owner can use a charitable remainder gift to avoid capital gains tax. Under present law, when appreciated property is given outright to a college, no capital gains taxes are payable when the property is given or later sold. The same rule applies when the donor retains the right to receive the income for life and the college has the remainder interest. No capital gains is paid either by the donor when given or by the college when later sold.

## HOW REMAINDER GIFTS CAN BE MADE

There are generally two ways in which a property owner can make a charitable remainder gift during life to a college.

- 1. One is by a conventional charitable remainder trust by which a donor transfers the property comprising the gift to a trustee usually a trust institution. The trustee (1) pays the income to the donor, (2) is responsible for the investment program of the trust and (3) administers the trust in accordance with the trust agreement. Upon the donor's death, the trust terminates and the principal is paid over to the college.
- 2. The other means is through what is frequently called a *life income agreement*. Many colleges have this type of program. The college is responsible for the investment and management of the property, and the college agrees to pay the income to the donor for life. When the donor dies, the institution becomes entitled to the income and is entitled to use both the income and/or principal for such purposes as the donor may have stipulated.

Such an arrangement gives the donor the personal satisfaction of making an important capital gift. His gross income is not reduced, his spendable dollars are actually increased because of income tax reduction and no principal is lost through capital gains tax when investment changes are made.






## **Another Dormitory Is Under Construction**

High Point College moves ahead in its program of development! The new dormitory pictured above indicates that the trustees are in earnest about th long-range plans. This is the second major building undertaken since the Golden Decade Program of Development was begun in 1965. The first building constructed under the program was the Horace S. Haworth Hall of Science dedicated on November 4, 1967.


The dormitory will house 138 students on four

The dormitory will house 138 students on four floors. In each section four rooms are built around a central lounge and bath. The entire dormitory will be carpeted and air conditioned. A large lounge on the first floor will add charm as well as utility to this building.

The College was fortunate to obtain a Federal loan for part of the cost of this dormitory. Golden Decade funds will be used to supplement the loan. A High Point construction firm placed the successful bid for the dormitory. The completion is scheduled for August, 1968. The student room rental fees for this dormitory will be increased substantially beyond that charged for rooms in other dorms.

## Constitution For Parents Associates Of High Point College

## ARTICLE I - NAME

The name of the organization shall be the PARENTS ASSOCIATES of High Point College.

## ARTICLE II - OBJECTS

The objects of this group shall be:

1. To generate and maintain the interest and goodwill of parents of current and former students of the College.

2. To inform parents about the College; it background, present work, and future plans.

3. To promote the development and advancement of the College by obtaining the cooperative assistance and financial support of the parents in planning and in carrying out its work and plans.

4. To act as liaison between individuals and groups and the College administration and faculty.

5. To encourage and recognize the work of any auxiliary group such as a Dad's Club, Mother's Club, and Area Chapters.

## ARTICLE III - MEMBERSHIP

Section 1. The Parents Associates shall consist of active and ex-officio members.

Section 2. The active members shall be as follows (1) All parents or guardians of present students and (2) parents of former students of High Point College who wish to be members.

Section 3. The ex-officio members shall consist of the following: The President of the College, The Dean of the College, the Business Manager, the Dean of Students, the Director of Public Affairs, the Alumni Secretary. Three of the ex-officio members, including the secretary of Parents Associates, shall be designated by the President of the College as voting members.

Section 4. The Parents Associates shall constitute a Resource Area of the Board of Associates of the College Development Program.

## ARTICLE IV - DIRECTORS

Section 1. The affairs of Parents Associates shall be managed by a Board of Directors consisting of 12 active members and the ex-officio members as set forth in Article III, Section 3.

Section 2. At the meeting when this constitution is adopted, six (6) members will be chosen for a one year term and six (6) for a two year term

Section 3. No elected member of

the Board of Directors shall serve for more than two (2) consecutive terms of two (2) years each.

Section 4. Vacancies on the Board shall be filled by a majority vote of the Directors present at any meeting in which a quorum is present.

Section 5. The Board of Directors shall meet twice each year, November and May.

Section 6. Seven (7) members of the Board will constitute a quorum.

#### ARTICLE V - OFFICERS

Section 1. The officers of the Associates shall consist of a president, 1st vice president, 2nd vice president, and secretary. They, with the exception of the secretary, shall be elected from or become a part of the 12 active members of the Board of Directors.

Section 2. The election of officers, other than the secretary, shall be held at each annual fall meeting of the Parents Associates. The Director of Development shall serve as secretary.

Section 3. No officer except the secretary shall serve more than two (2) consecutive terms.

Section 4. The president of the Associates is its nominal head and shall discharge the usual duties of this office.

Section 5. The vice presidents shall assist the president in every way to carry out his duties and responsibilities

Section 6. The secretary shall keep all records: act as advisor to the Board of Directors; be the general agent of the Parents Associates, to work with the Alumni Executive Secretary in integration of local groups of parents with alumni work; direct fund appeals, receive all contributions, and make an annual report to the Board of Directors and to the President of the College.

## ARTICLE VI - EXECUTIVE COMMITTEE

Section 1. The president, first vice president, second vice president, secretary, and two voting ex-officion members of the Board appointed by the President of the College (including the secretary) shall constitute the Executive Committee of the Parents Associates.

Section 2. The Executive Committee may act for the Board of Directors between meetings but such actions shall be reported to the Board for approval at a semi-annual meeting.

Section 3. The Executive Committee shall also act as the committee for parents in the Development Program of the College. It may be supplemented when necessary.

## ARTICLE VII - FUNDS

Section 1. All funds raised by the Parents Associates will be collected in the name of the College.

Section 2. The Board of Directors may recommend objects or designation of funds.

Section 3. The cost of maintaining the Parent Associates will be paid by the College Development Program.

#### ARTICLE VIII - PUBLICATIONS

The BULLETIN or any similar publication which may succeed it, shall be the official organ of the Parents Associates. Notice therein shall be official notice.

## ARTICLE IX - MEETINGS

Section 1. An annual meeting of Parents Associates shall be held each year in connection with Parents' Day at the College.

Section 2. The parents present shall constitute a quorum.

Section 3. The officers and Board members shall be elected from a slate presented by a Nominating Committee previously appointed by the President of the Parents Associates. They will take office following the annual meeting when elected.

## ARTICLE X - DEVELOPMENT PROGRAM

Section 1. The president of the Parents Associates or some member of the Board appointed by him shall be the official member of the Board of Visitors of the College.

Section 2. The Executive Committee shall constitute the Committee on Relations to work with the total Development Program of the College.

## ARTICLE XI -AUXILIARY ORGANIZATION

Any group of parents desiring to become an Auxiliary Organization either as a Chapter or a Club may do so by making application to the Board of Directors. (For example: A Dad's Club, A Mother's Club, Washington Area Chapter, etc.)

## ARTICLE XII - AMENDMENT OF CONSTITUTION

The constitution may be amended by a majority vote of the Board of Directors upon due notice mailed to each member two (2) weeks in advance of the meeting at which it will be voted upon. 91 'ON

#### THIS YEAR

The Horace S. Haworth Hall of Science which will house Chemistry, Physics, Botany, Zoology, and Mathematics, is in final stages of completion and will be ready for occupancy at school opening in September.

The Dennis H. Cooke Hall, the old Science and Home Economics Building, has been officially named The Dennis H. Cooke Hall and will be remodeled to house the Departments of Business Administration, English, and Sociology.

The Golden Decade Development Program continued as the clean-up campaign was held in High Point with eighty workers soliciting more than 300 individuals and businesses.

The Second Annual Development Conference was held at the New South Motor Inn on November 4, 1966, with 88 participants representing nine resource areas.

The Conference for Trustees, which was held April 28-29, 1967, marked the first attempt to bring together the trustees of the Methodist Colleges of both Conferences in the State of North Carolina. Fifty-nine trustees were present.

The Sears, Roebuck Store was completed and the grand opening held February 15, 1967. Sales volume for the first three and one-half months met expectations.

The Church Management Institute was held on the campus October 2-7, 1966, with 29 ministers from the Western North Carolina and North Carolina Conferences attending. It received high praise with strong recommendations that it be continued on a permanent basis.

Championship Base Ball Team — High Point College was the Carolinas Conference Champions and runner-up in District 26, NAIAA.

The Silver Anvil Award was presented to High Point College by the Public Relations Society of America for "outstanding public relations performance in promotional publicity — non profit" in the Golden Decade Development Program.

#### **NEXT YEAR**

A Women's Dormitory, to house approximately 130 students, has been approved for construction to be ready for occupancy in the fall of 1968. A 3% federal loan for \$435,000 has been awarded by the Department of Health, Education, and Welfare for construction of the women's dormitory. Golden Decade funds will be used to supplement this loan.

The Second Church Management Institute will be held on the campus October 9-12, 1967, in the Horace S. Haworth Hall of Science.

The Third Annual Development Conference of the Golden Decade will be held on Monday, October 2, 1967, in the Horace S. Haworth Hall of Science.

Parents' Day will be observed November 4, 1967. Over 2,000 parents will be invited to visit on the campus to meet faculty, parents, and trustees present for this occasion.

The Dedication of the Horace S. Haworth Hall of Science and the Dennis H. Cooke Hall will be held on Parents' Day, November 4, 1967.

The College Coordinating Council was created with Dr. James Fowler, as secretary. The four Methodist Colleges of the North Carolina Conference belong to the council — Brevard, Greensboro, High Point and Pfeiffer.

Remodeling of Dennis H. Cooke Hall to accommodate the Business Administration, English, and Sociology Departments will be complete for the beginning of the second semester in January.
