Q&A

with George Erath

High Point College's Aspire Campaign, a \$20 million major gifts campaign, has surpassed its first phase goal of \$10 million in gifts and pledges 17 months ahead of schedule.

The first phase of the campaign, which was unveiled in November, 1987, was scheduled to run until May 31, 1991. However, the Aspire Campaign, which is being conducted by the college's Office of Institutional Advancement, has already raised over \$10.3 million.

One of the major reasons for this success is Aspire Campaign General Chairman George S. Erath, a 1952 alumnus of High Point College and a member of the college's Board of Trustees. Whether it's in his role at the college, his duties as Chairman of the Board of Erath Veneer Corporation of Virginia, or his numerous other commitments to civic and charitable organizations in the High Point area, Erath possesses a strong but soft-spoken kind of leadership that prompted High Point Schools Superintendent Owen Phillips to say of Erath: "Perhaps more so than any other person in the city at this moment, he's just THE man around town."

HIGH POINTS: With a lofty target of \$10 million set for the first phase of the Aspire Campaign, how was the college able to surpass the goal so far in advance?

ERATH: Basically, it was because so many people put forth so much effort into the campaign. Sometimes, I think the college sells itself short. There is a tremendous number of people out there who have a warm spot in their hearts for this institution. So it should be no great surprise to see this level of commitment to the college's future.

HIGH POINTS: As Chairman of the Aspire Campaign, have there been any surprises or disappointments during the first phase?

ERATH: Most of the surprises have been pleasant ones. Several times, we would receive a gift from someone that wasn't familiar to us and we would have to go back and see what the connection was. It makes you wonder how many potentially interested people are out there who haven't been approached.

HIGH POINTS: Despite the success of the Aspire Campaign, many unfinished fund-raising projects still exist, such as the new athletic facility. How does this fit in with the college's plans for future fund-raising programs?

ERATH: You must have priorities in any fund-raising program. But you don't want to cloud the whole picture with individual priorities. President Martinson has set the vision for the college's future needs. Then you need to find people who have specific interests among the total needs. When John Lefler, the college's Vice President for Institutional Advancement, approaches someone, he doesn't talk so much about the college as he does about that particular individual's interests. From there, he guides them into a program that the individual and the college both share an interest. This is a sound philosophy to follow.

HIGH POINTS: What role have High Point College's alumni played in the Aspire Campaign?

ERATH: It's difficult to overestimate their role. Number one, the alumni have been most generous in their giving. Beyond that is the great number of alumni who have participated. Who is to say what kind of opportunities each individual has to give? It's not just how much a person



gives. It's also how many people participate and share the vision. We have found that there is a tremendous amount of people out there who appreciate the opportunities High Point College has helped open up for them. This has been shown throughout the campaign. The success of the campaign has hinged on the great number of people involved in the project.

HIGH POINTS: How do you believe the gift programs at the college could be improved?

ERATH: We need to get in a better position with grant participation from outside sources, which requires time and manpower. As a result of the current study being performed by The National Commission on the Future of High Point College, the college's strengths and weaknesses will be identified. Improvement is a matter of capitalizing on strengths and strengthening weaknesses.

HIGH POINTS: Of the monies that have been received throughout the campaign, what area of giving has had

the greatest impact on the college’s future?

ERATH: Without a doubt, alumni giving. Anytime you go to a foundation for a possible grant, it wants to know what percentage of your alumni participates. I can’t overemphasize the leadership of Dr. Martinson and Mr. Lefler in this area. They have set the tone and we have attempted to execute the vision.

HIGH POINTS: Have there been any other benefits from the campaign besides financial ones?

ERATH: Success breeds success. So you go back to self-evaluation and ask what is the potential role of High Point College in higher education and the community. None of us has recognized how great that potential is. As a result of the success of the first phase of the campaign, you realize how healthy the college is. It’s a reassurance that you’re on the right path. Your leadership has set the proper goals. Your faculty and student body are strong. And everybody seems to be headed in the same direction — upward.

HIGH POINTS: Where does the campaign go from here?

ERATH: That will be determined as a result of the National Commission’s report that will set the goals and direction for the second phase. But we won’t be getting away from the vision Dr. Martinson had when he came here. The National Commission will be establishing ways of fulfilling his vision more effectively.

HIGH POINTS: As closely as you have been involved with the college over the years, what kind of vision do you have for the college in the future?

ERATH: I see High Point College as one of the top private colleges in not only the state of North Carolina but the entire Southeast. An important part of that position will be the col-



lege’s relationship with the United Methodist Church. As we have seen countless times in our society, the relationship between business and ethics is very important. At a church-related school, students get exposure to developing ethically-related behavior patterns. That’s the kind of balance I received from my education at this school — knowledge combined with ethical practices. You only get this kind

of balance at a church-related college. The church is the conscience of the college.

In High Point, High Point College should be the center of cultural activity. It can be such a fantastic resource for the community. Once a new fine arts center is built, perhaps the college should be the new home of The North Carolina Shakespeare Festival, as well as other cultural activities our students could be exposed to. And think of all the amenities students will have once the Millis Center is completed. You’re enhancing the physical activity of all students through this project.

I don’t think there’s any end to what High Point College can be once it sets its mind to what it wants to achieve.

Campaign Surpasses First-Phase Goal

With High Point College's Aspire Campaign already 17 months ahead of schedule with over \$10.3 million raised, John Lefler, Vice President for Institutional Advancement at the college, is naturally quite pleased with the campaign's progress. But he also knows there is much more work yet to be done.

"Anytime an organization has this level of success in a fund raising effort, credit must be extended to all of those who made it possible," said Lefler. "The Board of Trustees, alumni, corporate and private donors, and the church have embraced this Aspire project and made it successful.

"The college is in the enviable position of having a capacity enrollment, which in turn has placed a greater demand on our facilities, particularly those that are related to athletics. Along with scholarship aid, clearly the most immediate need requiring private funding support is the Millis Center. Both of these projects impact directly on the quality of life of our students and have been specifically targeted by the Board of Trustees as primary areas in fund raising."

Over \$2.1 million has been raised toward the \$5.5 million James H. and Jesse E. Millis Athletic and Convocation Center. The project calls for renovating and expanding Alumni Gymnasium and adding a new Olympic-size pool, handball courts, fitness center, and other facilities.

Besides the \$2.1 million raised for the athletic center, the first phase total includes over \$4 million in unrestricted and special projects funds and more than \$2.8 million for scholarships.

During the campaign, the college has received approximately \$900,000 in designated and undesignated funds from the two United Methodist Church conferences in North Carolina.

Money raised in the Aspire Campaign will go toward such projects as the new Men's Residence Hall, the Millis Center, a new fine arts center, renovation of historic buildings on campus, and the development of the Winston-Salem campus. Endowed funds for scholarships, an honors program and faculty development are also included.

The campaign has been divided into two phases with goals of \$10 million each. The first phase began in November 1987 and was to end in mid-1991. But last December, the goal was surpassed with gifts and pledges totaling more than \$10.3 million.

Before the second phase begins, college officials will evaluate contributions to the campaign and the school's needs. The needs may change as well as the phase two goal of \$10 million. The college is awaiting the final report from The National Commission on the Future of High Point College to see what direction the fund-raising campaign should take.

College Encourages Non-Cash Gifts

In an effort to stimulate additional resources for funding the Millis Athletic-Convocation Center, the College has launched a program aimed at encouraging gifts of a non-cash nature.

"Basically we are asking alumni and selected donors to consider gifts of their assets which are no longer needed or desired," said John Lefler, the College's Vice President for Institutional Advancement.

"Often a person will have a piece of real estate, a paid-up insurance policy, securities which have appreciated highly, or a collection of valuables which, if given to the College, would represent a substantial contribution. In most cases, I would think that a donor can make a non-cash gift much more easily than writing a check for what would be an even smaller amount than

the value of the non-cash item."

Lefler pointed out that donors often are unaware of the income and estate tax advantages and incentives for making gifts which are non-cash in nature. "On one donor visit when the individual was struggling with how much to give to our Aspire Campaign, I happened to suggest that he give us something that he didn't want or need anymore. It was as if a totally new option opened up for him."

"Would the College be interested in several undeveloped lots?" the donor inquired. Lefler said that not only was the College interested in the lots, but in a matter of a few weeks the lots were received from the donor and sold to an interested buyer creating a scholarship in the name of the donor.

Lefler said that many of the gifts for the Aspire Campaign have come from similar circumstances. Since the trustees have targeted the development of the athletic-convocation center as the primary fund raising need for the next twelve months, donors of non-cash gifts are encouraged to allow the College to use the proceeds from their gift for this particular project.

Campaign Chairman George Erath '52 said that the College is especially adept at handling this type of gift. He said that over the years the College has made a special effort to convert non-cash items into usable cash for the College's programs.

"It may not happen every day," Erath expressed, "but hardly a week passes that the College is not a recipient of securities or something of appreciated value which the donor can give as if it were actually cash.

"As far as I am concerned," Erath concluded, "it is the best way for a donor and the College to benefit from a gift opportunity."

Student-Athletes Are Honored At High Point's Final Game

National Commission on the Future of High Point College

The National Commission on the Future of High Point College is scheduled to issue its final report to the college's Board of Trustees this spring.

The commission is made up of 144 members from 24 states. Members of the commission are drawn from business, government, the professions, education, college alumni, students, faculty and friends, and the United Methodist Church.

Commission members have been asked to assess the quality and scope of the college's academic program, the extracurricular experiences offered students, including athletics, and the college's impact on the community and region.

Most of the commission's work has been carried out through six committees: 1) The Mission and External Environment Committee; 2) The Academic Program Committee; 3) The Student Life Committee; 4) The Campus and Community Relations Committee; 5) The Physical Facilities Committee; 6) The Development Committee.

"I have been most enthusiastic about the work which has been done by the Commission during the past year," said High Point College President Dr. Jacob C. Martinson. "I look forward to the recommendations we will be receiving from such an outstanding group."

Panther Peaks

A capsule summary of intercollegiate sports news at High Point College:

Men's Basketball: The Panthers, which had won three consecutive Carolinas Conference Championships, struggled to an 8-17 finish this season, including a heartbreaking 77-75 loss to Mount Olive in the opening round of the Carolinas Conference Tournament. Senior guard George Byers was the Panthers' top offensive player, averaging 20.5 points and 5.1 rebounds per game. Sophomores Jay Witmer and Terrence Knuckles averaged over 12 points a game each and provide a solid nucleus for next season.

Women's Basketball: The Lady Panthers finished with a 17-12 record, their best mark since the 1980-81 squad. Senior Tracy McIver and sophomore Ingrid Hendrix were named to the All-Carolinas Conference team.

Baseball: The Panthers return six everyday starters from last year's 22-15 squad which advanced to the NAIA District 26 finals. The Panthers' top two hitters from a year ago — all-conference second baseman Chris Chatterton and centerfielder Orlando Barrios — return along with standout third baseman Billy Wilson.

Track: The two-time defending Carolinas Conference champions will be led by junior John High, a top cross country runner who will compete in the 1,500 and 800-meter events, along with the triple and high jumps.

Men's Tennis: Under the guidance of Coach Ray Alley, the Panthers were off to a strong 5-1 start at press time following a second-place finish a year ago in the Carolinas Conference.

Women's Tennis: The defending Carolinas Conference champions return a strong squad which advanced to the NAIA National Tournament a

year ago. Kitty Steele, last year's Carolinas Conference Coach of the Year, returns to lead the Lady Panthers.

Gene Littles '69 named head coach of the NBA Charlotte Hornets: Littles, a three-time NAIA All-American, is in the NAIA Hall of Fame. His No. 14 jersey is retired at High Point College. He is the college's all-time leading scorer.

He played professional basketball for six seasons in the American Basketball Association and has been a head coach at North Carolina A&T and with the NBA's Cleveland Cavaliers.

Littles came to the Hornets as a player personnel director and assistant coach in 1988. He was named head coach in January after Dick Harter was fired.

Panthers' Shea Receives Academic/Athletic Award

Theresa Shea, a tennis and academic standout at High Point College, received the 1990 Murphy Osborne Award for overall academic-athletic excellence.

Carolinas Conference officials presented the award to Shea at a luncheon kicking off the 50th annual men's basketball tournament at High Point College.

Shea, a senior from Raleigh, has played No. 2 singles and doubles on Panther teams which advanced to the NAIA national tournament in Kansas City during her freshman and sophomore seasons. She also has maintained a 3.85 overall grade-point average during her three-plus years, which included a year-long stay in Leeds, England, for overseas study during her junior year.

Shea is also involved in various campus clubs and organizations and is a Millis Scholar-Athlete. Following her graduation in May, Shea hopes to pursue a graduate degree.

"She is a young woman with high moral character, ambitious goals and one who is currently involved in attaining those goals," HPC women's tennis coach Kitty Steele said.

The Osborne Award, presented annually by the Carolinas Conference, honors the league's top student-athlete. The award is open to any league senior, male or female, who excels academically and athletically. A minimum 3.0 overall GPA is required. The winner must be in the top 15 percent of his/her class and a starter or important reserve player. The award is named after the longtime former conference commissioner.

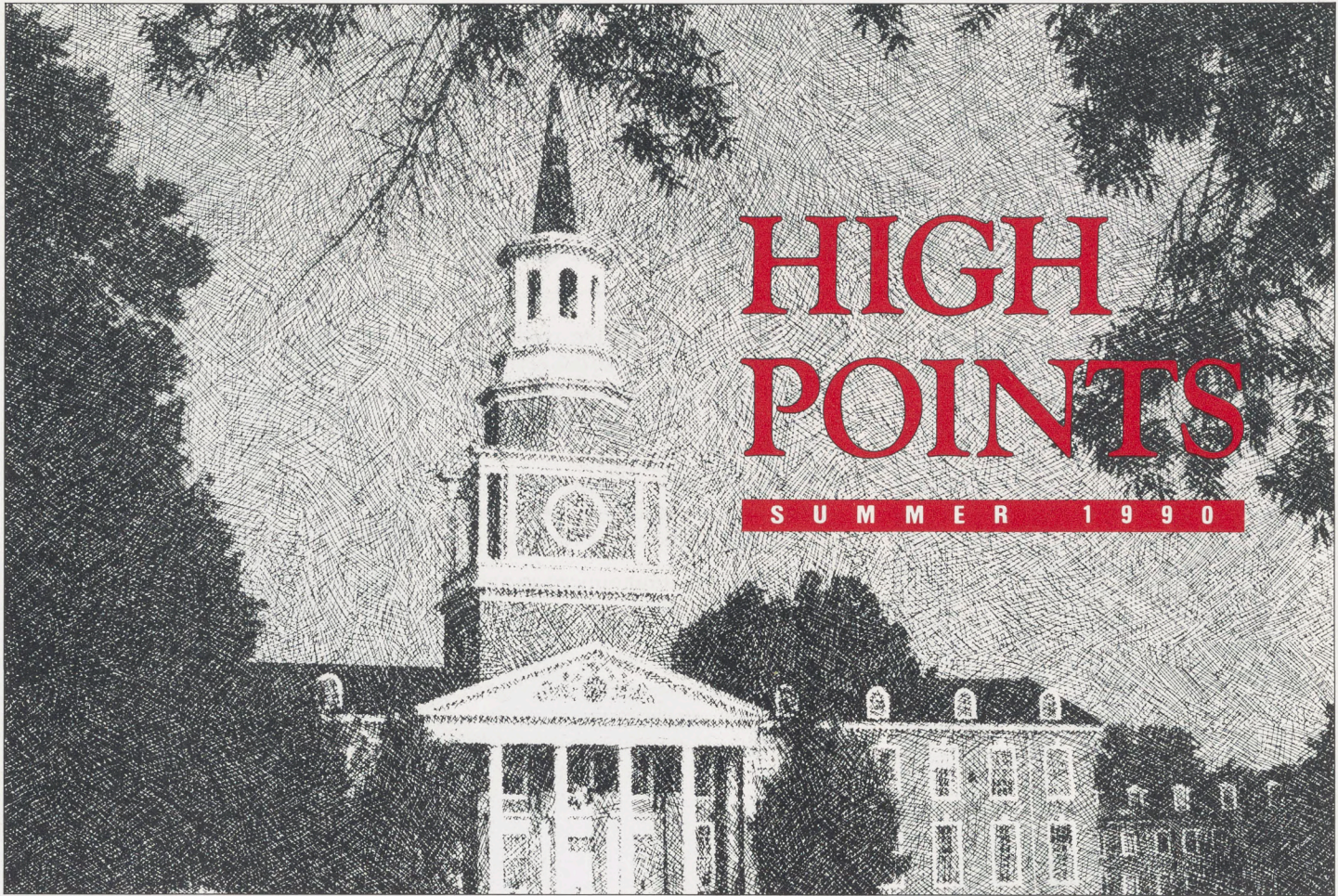

National Commission



Commission Unveils Final Report

The National Commission on the Future of High Point College unveiled a plan on March 27 in the Wrenn Building to propel the college into the top ranks of higher education in the Southeast and the nation.

The centerpiece of the commission's recommendations are a continuing emphasis on academic excellence and a distinctive academic approach that imaginatively blends liberal arts and professional preparedness.

These key objectives will be implemented by more than 60 specific recommendations in ten "strategic directions" established by the National Commission.

The final report of the National Commission was presented by Chairman Hugh L. McColl, Jr., Chairman and CEO of NCNB National Bank, and Richard A. Kampe, Executive Vice President of External Relations, R. J. Reynolds Tobacco Company. Accepting the 80-page report for the College were Board of Trustees Chairman W. Roger Soles and President Jacob C. Martinson, Jr.

Presentation of the report culminated more than ten months of work by more than 150 members from 25 states.

In presenting the report at the final meeting of the National Commission, Chairman McColl said the College is "turning the rhetoric of change into the reality of academic excellence through the work of the National Commission."

"We're dreaming big dreams for the College and the best thing about these dreams is they are achievable," said Martinson about the plan, which was the first of its kind for a North Carolina institution.

Among the key steps to be taken by High Point College, are:

- A significant five-year expansion of the faculty;

- The current size of the traditional student body should be maintained in order to concentrate on increasing the admissions profile of the student body;
- The addition of a Master's Degree program for working professionals to be phased in over several years;
- The report also announced an agreement with Westminster College, Oxford, England beginning in the fall of 1991 through which High Point College students will spend a semester studying at the institution in England. The program may be expanded in the future so students from the English college will spend a semester at the North Carolina school. Eventually, the High Point College degree in international relations will be offered to both English and American students at Oxford;

- A continued improvement in the ratio of faculty to students; and
- Continued increases in faculty salary until the College ranks among the top four private institutions in North Carolina.

Chairman Soles reported to the National Commission that the College's Board of Trustees on March 14 unanimously adopted the report "as the guiding policy for the College, and resolved to begin implementing it with all deliberate speed."

Assisting in the official presentation of the report were five chairmen of the National Commission's committees, including:

Dr. John L. McWhorter, Academic Program; Edward Harriss Covington, Campus and Community Relations; George S. Erath, Development; S. Dave Phillips, Facilities; and James H. Millis, Sr., Student Life.

High Point College Action Plan Recommendations



- Intensify its emphasis on the improvement of academic quality.
- Assume a leadership role in emphasizing ethical concerns throughout the curriculum.
- Expand upon the new curriculum's emphasis on communications skills.
- Integrate more closely the student life and academic programs, and increase student life activities appropriate for working adults.
- Expand and strengthen its internship program in cooperation with corporate, professional, governmental, and charitable sponsors.
- Build upon its highly successful undergraduate program for working adults by adding a Master's Degree designed to integrate professional skills with fundamental liberal arts concepts.
- Deepen the global awareness of undergraduate students and broaden their opportunities for international experiences.
- Become an educational and cultural hub of the community, enhancing both student life and the community through more frequent concerts, lectures, and entertainment programming of regional and national interest.
- Take a long-term approach to the physical development of the campus, planning for a more unified environment to improve the campus quality of life, and to become more of an attraction to visitors.
- Define the goals of its educational program and, to the extent possible, establish ways to measure its effectiveness.

Commencement

Spaulding Addresses College's Largest-Ever Graduating Class

Richard L. Spaulding, president of USAir Leasing and Services, told 332 students in the largest-ever graduating class at High Point College to never feel that someone else holds an edge on them.

Spaulding, the father of four daughters, all of whom graduated from High Point College, delivered the May 5 commencement address before a capacity crowd in excess of 2,500 family members and friends gathered in Alumni Gymnasium for the ceremony.

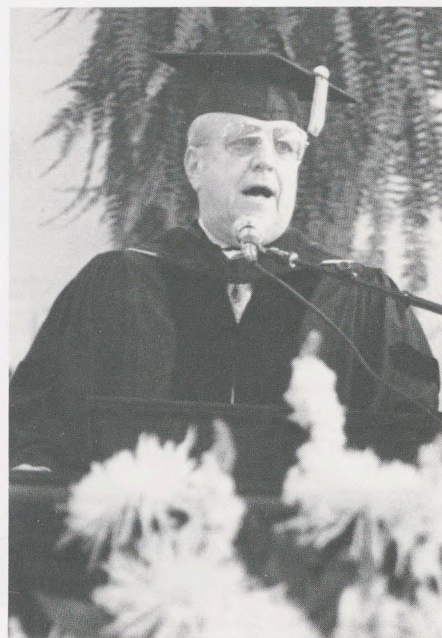
Spaulding attributed the success his four daughters achieved in their chosen fields to High Point College. "High Point gave them the foundation with which to go out and compete with graduates of other fine schools, including those from much larger, better

known and even more prestigious universities," Spaulding said.

Spaulding suggested that the small college environment helps instill leadership and initiative qualities, and that High Point College helps strengthen moral guidelines.

"You, too, should be grateful for what this college has given you and never, never feel that someone from a larger, or better known school has an edge on you. Instead, you might feel sorry for them," Spaulding said.

"They probably never had the advantage of small classes and close interaction with professors. They had limited opportunity to display leadership and initiative and were more apt to

have been just another face in the crowd or a number in a class room.

"Leadership and initiative are qualities that companies and organizations are looking for when hiring employees that they feel will contribute, and not just coast along.

"High Point has also strengthened the moral guidelines that were instilled by your families. In the years to come you will be required to make difficult decisions. Morality is quite often a major factor in making those decisions.

"In short, High Point has given you a foundation that will last a lifetime," Spaulding said.

High Point College senior class president C. Thomas Joseph offered some advice during his address to the commencement audience. "It's not how much money you make or how many people you have working under you," said Joseph. "The real success in life is found in the integrity each of us holds."

Fifty-six students graduated with academic honors.

Honorary Degrees

G. Howard Allred, Senior Minister of First United Methodist Church in High Point, and Jim C. Gilland, Greensboro District Superintendent for the Western North Carolina Conference of The United Methodist Church, were awarded honorary degrees by High Point College during commencement exercises.

Allred, who received the Doctor of Divinity degree, is a native of Greensboro and received his Bachelor of Arts degree from Guilford College in 1949. He was awarded the Master of Divinity degree by Duke University in 1952.

Allred has been Senior Minister of First United Methodist Church in High Point since 1987. Prior to 1987, Allred was Northeast District Superintendent for the Western North Carolina Conference of The United Methodist Church and had served United Methodist congregations in six cities.

Allred is a member of the High Point College Board of Visitors and the Chas. E. Hayworth Sr. Memorial Chapel Board of Advisors at the college.

Gilland, who received the Doctor of Divinity degree, is a 1955 graduate of High Point College. He was awarded the Master of Divinity degree by Duke University in 1959.

Gilland has served as Greensboro District Superintendent since 1984. Prior to 1984, Gilland pastored United Methodist congregations in seven cities. Gilland is a member of the High Point College Board of Visitors.

High Point College President Dr. Jacob C. Martinson, in announcing the selection of the degree recipients, said, "We are honoring two long-time supporters of the College who happen to be alumni. We are proud of their dedication and accomplishments in the life of the church. The College is honoring itself in honoring their many years of service."

Law Receives Slane Teaching Award

Mr. Ronald M. Law, assistant professor of theatre arts, was presented the Meredith Clark Slane Distinguished Teaching-Service Award during commencement exercises.

The Slane Award recognizes outstanding classroom performance, interest in students as expressed through academic advising and sponsorship of student organizations, participation in campus and community activities, and professional growth.

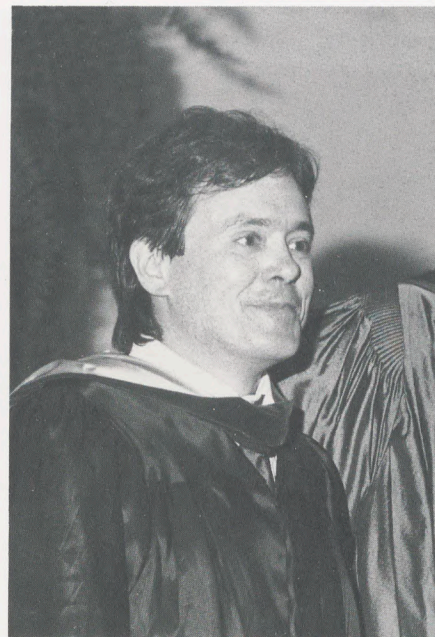
Law joined the High Point College faculty in 1984. He received his Master of Fine Arts in Acting and Directing from the University of North Carolina at Greensboro.

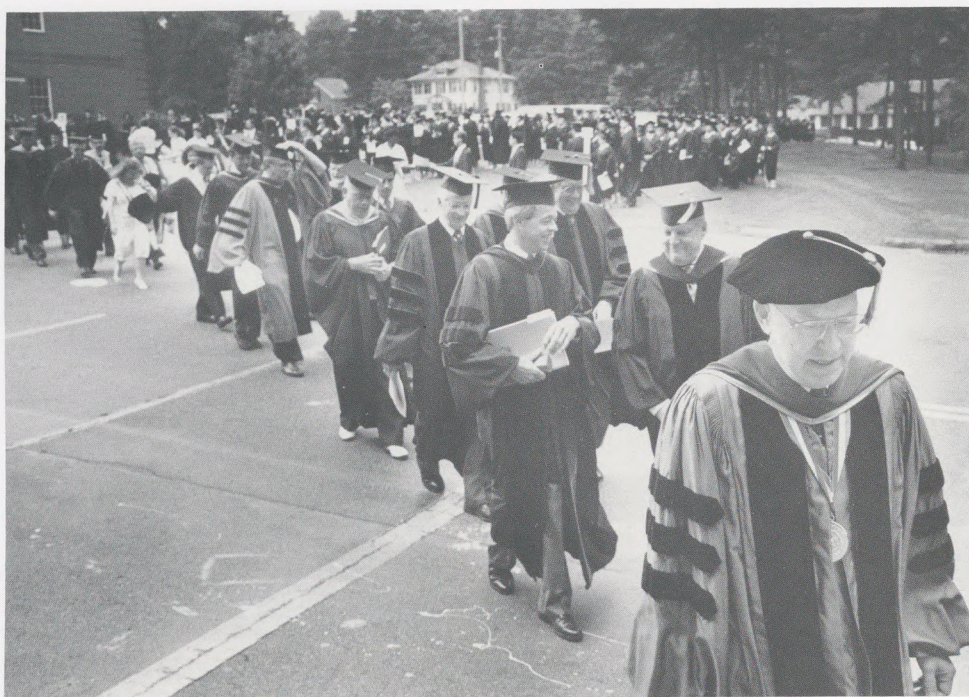
Alvarez Named 1990 Outstanding Senior

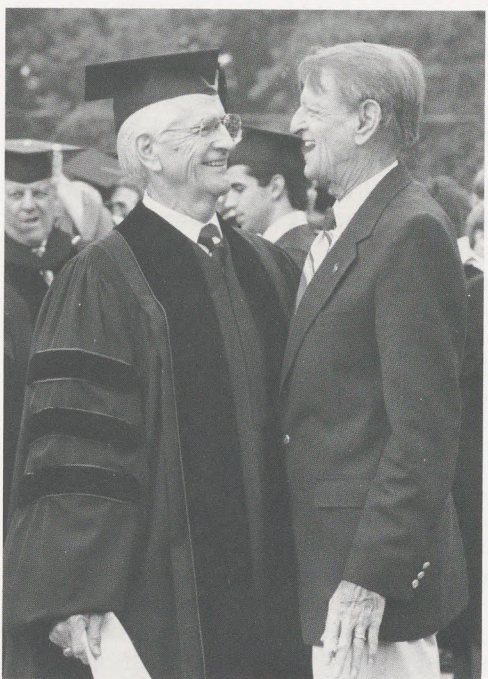
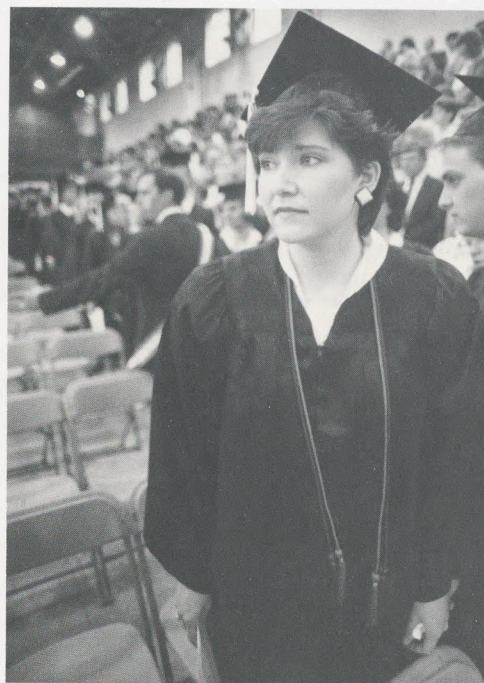

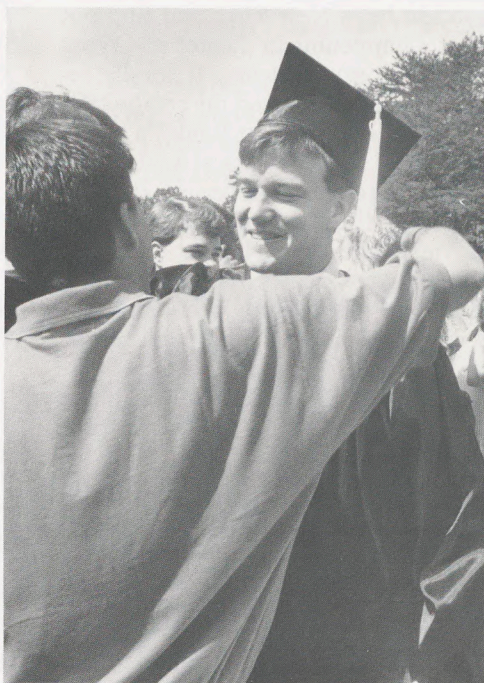

Faculty Profile

This Guy Loves New York—Even Off-Off-Broadway

Take three failed baby boomers who are convinced that the body of John F. Kennedy is being kept alive at a local veterans hospital, mix in plenty of dark humor, and what have you got?

You've got "A Slim & Crooked Genius," the unlikely off-off-Broadway play that ran three nights at New York City's West Bank theater and is now being considered by a major motion picture company. Ron Law, assistant professor and head of the theater program at High Point College, directed the offbeat production.

The play was the 45th production directed by Law, but it was his first in New York's theatrical hotbed. (Lynn Terry Jr., a student at High Point College, served as stage manager for "A Slim & Crooked Genius.")

"It was exciting," Law said. "It was good to be in New York and find out what's happening in theater and bring it back to my students. It totally reenergized my mind and my creativity."

Law called the West Bank "a pretty hot place" in the theatrical world, with a good, steady audience of theatergoers, casting agents, directors and movie producers. Theater staff annually review nearly 700 scripts, Law said, and select only a handful for performances at the West Bank. In the last two years, six of the plays performed there have since been made into Broadway or off-Broadway productions.

Representatives of Lorimar Pictures were among those who saw "A Slim & Crooked Genius." The movie production company is now reviewing the play's script for a possible movie.

Law said audiences — as did he — found the play's black humor hilar-

ious. "That's what drew me to it," he said. "I thought the premise was bizarre, yet workable. I wouldn't have done it just to have the opportunity to work in New York — the play had to be good."

Law's opportunity to direct the play in New York came through someone he knew, as is often the case, he said. "You can't just go and interview to be a director," he explained. "They need to see some of your work."

Last July, Tod Reichert, who had performed in Law's thesis production six years ago at the University of North Carolina at Greensboro, asked Law to direct the play. Reichert and two others had optioned the script from playwright Joel Drake Johnson. Reichert also would perform in the play's premiere at the West Bank.

Once Law agreed to direct the play and the script was accepted by the West Bank, Law had to make arrangements with High Point College to miss some teaching time so he could go to New York.

In the meantime, though, Law had to settle for the next best thing to being there: He made three or four complete script revisions over the telephone. "That's not all that easy," he said. "There's so much you can tell when you read something and you can see the person who's saying it. There's a lot you can miss (on the phone)."

Rehearsals began in mid-December, Law said, and the play premiered in

January for performances on three consecutive nights.

Law was pleased with the favorable response from the New York crowds. "This is live theater, and you can work and work and work, but you never know what an audience will accept," he said, particularly in a play with a premise as bizarre as that of "A Slim & Crooked Genius."

For his part, Law was offered the chance to stay in New York and direct another play, but he had to decline so he could return to High Point and his classes. Yet another opportunity, he said, could be in the offing in the summer.

Law, 41, has directed a number of professional productions throughout the South, and he would welcome the opportunity to do more directing, he said. "I realize, though, that I love to teach, and I don't want to give that up."

Law attended Kent State University and received a master of fine arts degree from the University of North Carolina at Greensboro. From 1979 to 1981, he served as program director for the International Theater Institute of the United States. Law came to High Point College in 1984.

Theatrically, directing in New York may be Law's highest honor, he said. "It's New York," he said, "and you hear people say that if you can do it there, you can do it anywhere."

Smith Recipient of Science and Engineering Development Award

Dr. Gerald Smith, Assistant Professor of Biology, is the recent recipient of a Science and Engineering Development Award from the North Carolina Board of Science and Technology. The grant is for \$20,000 with \$9,500 to be matched by High Point College. The grant was awarded on a highly competitive basis and is designed for enhancing the college and university environment for both faculty and student research.

Dr. Smith, a native of Lexington, NC, received his Ph.D. degree from the University of Georgia. He earned an M.A. from Wake Forest University. He came to High Point College two years ago from Wake Forest University where he was a research associate in the laboratory of Dr. Walter Flory and a part-time faculty member. He does research in the field of cytotoxicity of plants and teaches general biology, botany, and genetics. Two of his students were awarded Yarbrough Undergraduate Research Grants by the North Carolina Academy of Science to do research in plant cytotoxicity this past year. Dr. Smith's grant will provide funds for him to do research full-time for two summers. It will also provide the Department of Biology with a new greenhouse, herbarium and cytology equipment, and microscope video equipment.

His research is specifically on a group of plants known as spider-lilies (*Hymenocallis*). They are exotic plants that inhabit the wetlands and aquatic systems of the southeastern United States and the Neotropics. They have attracted the attention of plant collectors, horticulturists, and taxonomists since colonial days, but the identities of most species have remained unclear.

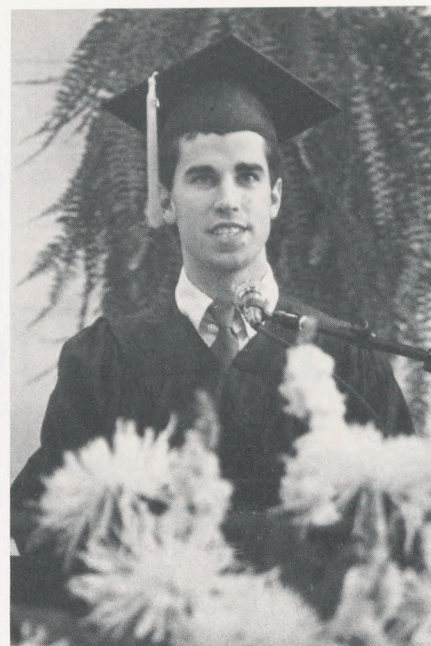
This grant will enable Dr. Smith to investigate further the biology of these plants. Field, greenhouse, and laboratory studies will be conducted by him and his students.

Myers, Ramke Awarded Fulbright Grants

High Point College faculty members Dr. Jean Myers and Dr. Ron Ramke have been selected to participate in Project India, a six-week summer study and all-expense paid tour across India awarded by the Fulbright program.

Myers, assistant professor of religion and philosophy, and Ramke, associate professor of sociology, will experience Indian culture and travel through the entire country during their six-week stay. They will participate in seminars on a variety of topics, including the impact of technology on traditional culture, the educational system, and religious practices. Myers and Ramke will also meet with key Indian officials and administrators.

Myers is particularly interested in the religious aspect of the trip. "Study in India will enhance the Religion curriculum at High Point College in two significant ways," she said. "First, it will enhance the World Religions course currently offered to Religion majors and International Business majors. An understanding of Eastern philosophies and religions is essential for these students. Second, study in India will enhance the Religion and Myth course currently offered to upper level students. This course explores myths from many different cultures as they relate to creation, suffering, death, and immortality. The religions of India play a major role in offering explanations for these universal human experiences."

Alpha Phi Omega, a national service fraternity, gives the award annually to the faculty member, administrator or student who has given the most outstanding service to High Point College. The award is presented in memory of the late L. E. Moody, who was the director of the college's American Humanics program until his retirement in 1973.

Joseph is president of the senior class and is past president of the Lambda Chi Alpha fraternity. He has also served as a resident assistant and as a reporter for *The Hi-Po*, the college's student newspaper.

Carroll, a High Point College alumnus, is Director of Teacher Education at High Point College. Carroll is one of nearly 700 faculty members being recognized nationally by the Sears-Roebuck Foundation for resourcefulness and leadership as a private college educator.

1990 Jefferson Award Presented To Rockwell

Christy Rockwell, a rising HPC senior from Binghamton, NY, was one of six people in the North Carolina Triad to win the 1990 Jefferson Award. Rockwell is the Triad's youngest recipient of the award this year.

The Jefferson Awards were established in 1972 to recognize contributions in the field of public service throughout the United States. These awards are part of the American Institute for Public Service.

Ms. Rockwell shared this honor with Dr. Bruce Thede, a biochemist with Ciba Geigy Corp., for his work with AIDS victims; William McDonald, a systems engineer with IBM Corporation in Greensboro for his work with children in crises; Kathy Parker, a coordinator for the Jerry Lewis Telethon; Mrs. Ernestine Glenn, an outstanding volunteer at the Cancer Patient Support Program at Bowman Gray School of Medicine; and Margaret Damon of Winston-Salem, volunteer lay therapist with SCAN (Stop Child Abuse Now) for her work with abused children and struggling parents.

Gart Evans, HPC Dean of Students,

nominated Christy for the award. Dean Evans felt that her role in organizing an extremely successful CROP Walk at HPC to fight world and community hunger qualified her for consideration. She was unaware of the nomination until she was notified that she was a winner.

"I had been involved with CROP Walk since I could barely walk," said Ms. Rockwell. "I always enjoyed being a part of it back home, and I thought it would be a good way to have fun and still help people."

Christy's original plan was for HPC students to participate in the community's CROP Walk. When she learned that the community project was scheduled during fall break, she suggested that a separate walk be set up for the students one week prior to the citywide walk.

With 125 students participating, they raised \$1,000. According to Ms. Rockwell, 25 percent of the proceeds stay in the community and 75 percent go to fight hunger overseas.

In addition to organizing this com-

munity service project, Christy is editor of the college yearbook, serves as president of the Society of Collegiate Journalists and pursues photography as a hobby.

Since junior high school, Christy has kept a journal, mostly for her own enjoyment; but she has found that it has been beneficial in helping to fine-tune her writing skills for her English communications studies. She would like to go into print journalism after graduation with a long term goal of working for a magazine such as *National Geographic*.

Each winner is given a bronze medalion donated by the Jefferson Mint, an engraved Jefferson cup and a winner's certificate. This award now places her in consideration for the 1990 National Jefferson Awards.

These prestigious awards were established by Samuel S. Beard, a former staff associate for the late Senator Robert F. Kennedy. Beard felt that we should recognize public service and work harder to attract young people to this worthwhile field.

Abernethy Receives Haverty Cup Award

Glenda J. Abernethy of Newton, a home furnishings marketing and business administration major at High Point College, has been awarded the Haverty Cup as the most outstanding 1990 home furnishings marketing graduate. The cup was presented at High Point College during Honors Day Convocation by Bill Todd, manager of Haverty Furniture Company in Winston-Salem.

During her four years at High Point College, Abernethy earned a 3.9 grade point average out of a possible 4.0. Abernethy is employed as Director of Advertising for Dixie Boat Works in Conover.

The Haverty Cup was established by Rawson Haverty, Sr., Chairman



of the Board of Haverty Furniture Companies, Inc., in 1988 to honor annually the most outstanding home furnishings marketing graduate. Each year the chosen student's name will be engraved on the cup, which will be on permanent display at the college. The student will also receive a \$1,500 cash award and an engraved replica of the cup.

William Levenson Scholarship Established At High Point College

Levenson & Klein Home Furnishings of Baltimore has established the William I. Levenson Memorial Scholarship at High Point College through a major contribution to the college's Aspire Campaign.

The scholarship is a tribute to William I. Levenson, retired president of Levenson & Klein, who died in November.

Levenson joined his family's business in 1946. His father, Reuben Levenson, and uncle, Joseph Klein, opened their first store in Baltimore in 1919. William Levenson was merchandise manager from 1952-1960 and then vice president until 1972, when he succeeded his father as president. During his tenure he helped build the company into a successful three-unit chain. He retired in 1980.

Levenson served as president of the National Home Furnishings Association in 1979. He helped spearhead the association's first National Sale event and was instrumental in developing the Ideal Home Furnishings Store program, designed to help NHFA members improve store management.

Levenson also was a charter member on the furniture marketing curriculum advisory board at High Point College and was instrumental in the development of the Home Furnishings Marketing program at the college.

"We at Levenson & Klein are truly inspired by the dedication and commitment that the late Mr. William Levenson showed to the Home Furnishings Industry," said Robert Marcus, president of Levenson & Klein. "We anticipate that this scholarship will help a future industry member start his or her career."

"I had the honor of working with

Mr. Levenson in the college's furniture program, and we will all miss him greatly," said John C. Lefler, vice president for Institutional Advancement at High Point College. "This scholarship will serve as a lasting tribute for his service to the furniture industry and High Point College."

Levenson Scholarships will be offered annually to residents of the United States who are entering the Home Furnishings Marketing Program at High Point College. Awards will be based on academic merit, as determined by the Office of Financial Aid at the college. Preference will be given to those qualifying students who demonstrate financial need through application to the Financial Aid office. The scholarship may be renewed annually for any recipient who satisfactorily completes the previous year's academic program.

Contributions will be added to the principal of the William I. Levenson Memorial Scholarship Fund at High Point College to enhance available scholarships for future students. The Aspire Campaign is a \$20 million major gifts campaign for High Point College being conducted by the college's Office of Institutional Advancement. To date, over \$10.3 million has been received in gifts or pledges toward the campaign.

Alumnus Establishes Major Scholarship For Iredell Students

The College has received notification from the estate of James Vernon and Emma Allison Robertson of Statesville that a bequest will be used to fund a new scholarship at the College. An in-

itial estate gift of over \$55,000 has recently been received and a second disbursement is expected to complete the funding for the Robertson fund.

Recipients will be selected primarily from the Iredell County area and will embody strong citizenship traits and academic promise. Financial need will also be considered in making the selection of recipients.

James Vernon Robertson graduated from High Point College in 1929, and he has been recognized for his contributions to the church and community. Both he and Mrs. Robertson died in 1989.

Hi-Po Captures National Award

The *Hi-Po* captured first place with special merit honors from the American Scholastic Press Association Awards competition.

The *Hi-Po* was one of six collegiate newspapers in the United States to receive the award among senior colleges with an enrollment between 1,700 and 2,500. First place with special merit is the top award presented by the American Scholastic Press Association. First place with special merit was given to publications that scored over 900 points on a 1,000 point scale and, in the opinion of the judges, was an outstanding example of a scholastic publication in format, content, and presentation.

"The staff is honored to be selected for this award," said Bobby Hayes, advisor to the *Hi-Po*. "The students were determined to upgrade the quality of this publication and this award shows the progress that has been made. We are looking forward to continued improvement in the product in the months ahead."

The American Scholastic Press Association serves over 2,000 schools throughout the United States.

Littles To Remain As Hornets' Coach

Gene Littles had the "interim" removed from his job in April.

It was announced at a press conference that Littles had accepted owner George Shinn's offer of a multi-year contract to be the Charlotte Hornets full-time head coach. Littles also had the option of moving back into the front office, but chose to remain on the sidelines.

"I finally get a chance to coach in the NBA," Littles said. "This is what I've always wanted. And it's special to be able to do it here (in North Carolina).

"I went to college here and played professional basketball here. North Carolina has always been my home, even when I've worked for other teams. I'll always live here."

Littles, 46, has strong ties to the Triad. He was a collegiate standout at High Point College from 1965-69. He played six seasons in the American Basketball Association, the first five with the Greensboro-based Carolina Cougars. He was head coach at North Carolina A&T for two seasons, the last in 1978-79.

"I just wanted the opportunity," Littles said. "Some guys never get the chance. I've been in the league 11 years and if I didn't take this offer, maybe another one wouldn't come along, or it would come when I was too old."

Shinn was impressed with the way the Hornets responded under Littles, who took over on an interim basis when Dick Harter was fired in late January.

"Gene has a good rapport with the players and they like him very much, as evidenced by the performance of our team," Shinn said. He referred to the club's six wins in March, the most wins in any month in their short history.

"Gene has proven he's the best coach we could possibly have," said Shinn, who interviewed no other candidates.



"The players have rallied around him and they really love him. That's the way I like to motivate people, through love and caring instead of fear. "A couple of months ago, I probably would have said that Gene is best-suited to the front office. He gets along well with everyone and has a knack of explaining a player's talent to people like me. I wish I could

clone him and put the other one in charge of the front office."

Littles came to the Hornets a year before they played a game, as director of player personnel. He oversaw their choices in the expansion draft that brought them Dell Curry, Muggsy Bogues and through a trade, Kelly Tripucka.



High Point College Winner of Joby Hawn Cup for 1989-90

For the ninth time since 1976, High Point College has been named the winner of the Joby Hawn Cup, awarded annually to the conference member which has the best overall athletic program in each of the conference's 11 sports.

Points are awarded on a first through last place finish. The honor was named for H. C. "Joby" Hawn, former commissioner of the Carolinas Conference, for his many years of service.

High Point swept five of the conference's 11 championships, taking honors in soccer, volleyball, golf, women's tennis and baseball. They tied for a sixth championship in women's cross-country.

"We're very glad to win the Joby Hawn Cup again. It points out the overall strength of our athletic program and the hard work and dedication of our athletes and coaches. We've been very fortunate over the past years to win the award nine times," said Jerry Steele, athletic director.

Point standings were: High Point College (53.5), Pembroke State University (44.5), Atlantic Christian College (38.5), Pfeiffer College (36.0), Belmont Abbey College (32.5), St. Andrews College (31.0) and Mt. Olive College (29.0).

Spring Sports at HPC Are Winners

High Point College completed its most successful spring season in athletics in recent years, winning Carolinas Conference championships in women's tennis, golf, baseball and finishing second in men's tennis.

Women's Tennis: The Lady Panthers had their most successful season ever, posting an undefeated 18-0 record in dual matches, winning the conference title and the District 26 championship. All six members of the team won All-Conference and All-District honors, another first. They include seniors Kandi O'Connor, Theresa Shea and Stacey Scherer, junior Mami Harada, sophomore Paivi Tapaniven and freshman Janna Sture. Coach Kitty Steele, in her 12th year, was named Conference and District 26 Coach of the Year.

High Point, ranked 10th in the nation in the latest poll, will participate in the NAIA National Tournament in Overland Park, Kansas, beginning May 21. It will be the eighth time in ten years that the Lady Panthers have advanced to the nationals. Their highest finish was fourth in the nation in 1982 and 1983.

Golf: High Point won its first Carolinas Conference title in golf since 1949 as well as winning the prestigious

Pembroke State Invitational Tournament. It marked the first time since the mid-fifties that High Point had won two golf tournaments in a single season.

One junior, three sophomores and a freshman comprised the team. Although no one made All-Conference, each player finished between seventh and fifteenth individually in the Conference tournament, making it truly a team effort. Woody Gibson, in his sixteenth year as coach, was named Carolinas Conference Coach of the Year.

Baseball: High Point finished third in the regular season in the Carolinas Conference, posting an 11-7 record. They put it all together during the conference playoffs, winning five games in three days. Along the way they defeated St. Andrews College twice in one day, St. Andrews being ranked ninth in the nation at the time.

Senior pitcher Steve Patton, junior outfielder Orlando Barrios and sophomore second baseman/pitcher Chris Chatterton received All-District and All-Conference honors. Jim Speight, in his 12th year, was voted District 26 Coach of the Year.

Men's Tennis: In their best showing in recent years the Panthers finished second in the Conference, with Pat Schramm receiving All-District 26 honors.

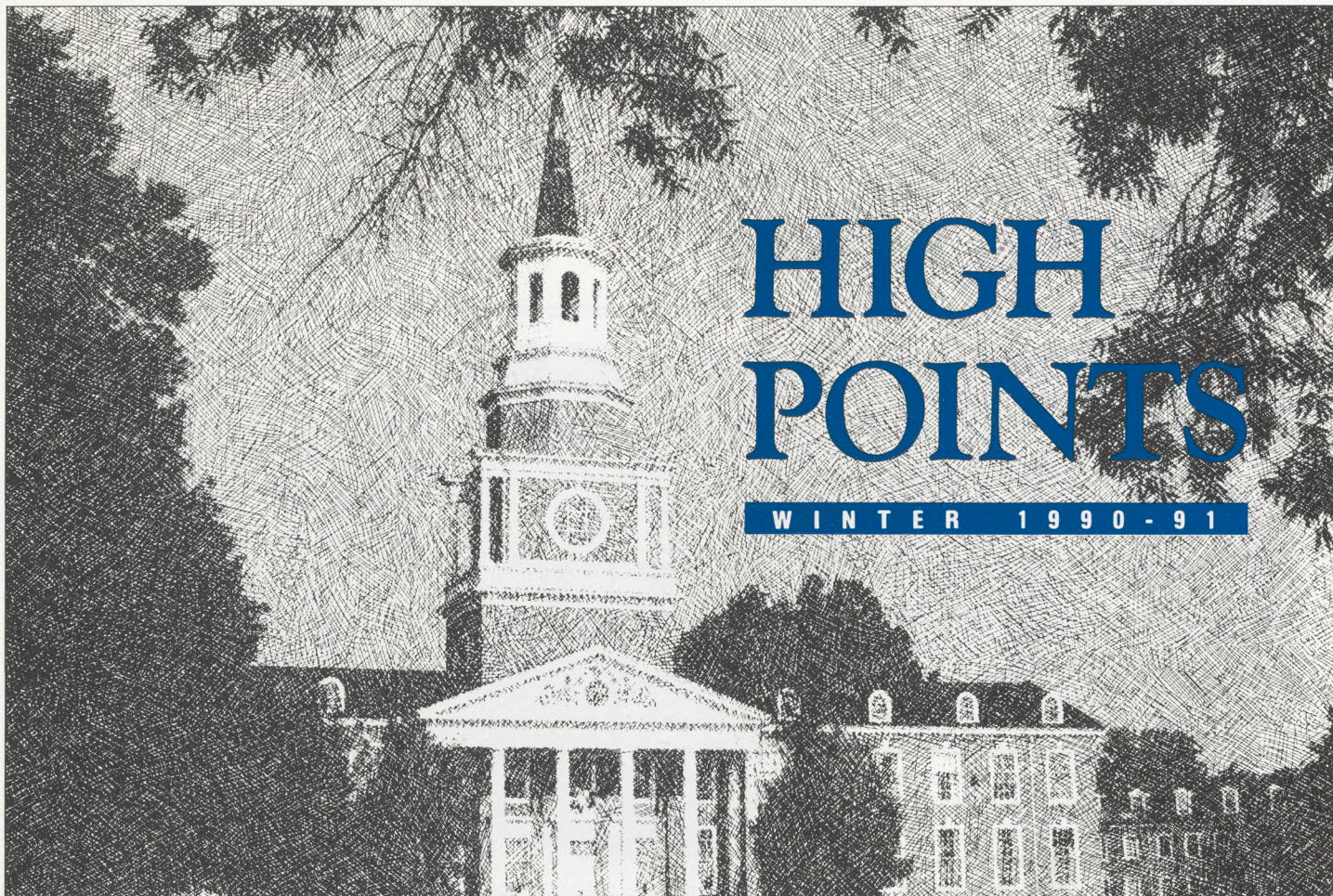

Montlieu Avenue to be rerouted around college

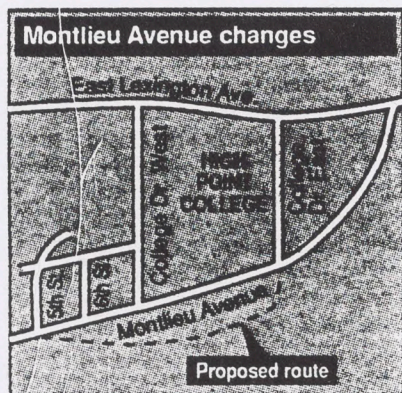
High Point College received a Christmas gift that school officials have dreamed of for many years.

The North Carolina Board of Transportation has agreed to allocate \$1 million to relocate Montlieu Avenue, rerouting the street around the campus. Presently, the street bisects the campus, running between Roberts Hall and the Haworth Hall of Science.

Under the Board of Transportation's plan, Montlieu would branch off from its present location at Fifth Street, go south of High Point College on Boundary Street and tie back in at the intersection of College Drive and Montlieu.

The transportation board plans for the state to begin buying right-of-way in 1992, with construction to start in 1993 and end in 1994. The decision came as the state board approved the 1990-91 Transportation Improvement Program, a seven-year master plan for road and highway construction.

College officials are thrilled with the decision for both aesthetic and safety reasons. With the rerouting of Montlieu, the campus can now be unified. Students will no longer have to worry about crossing a busy, dangerous street to get to classes and without the whirl and noise of traffic, the campus will possess a more tranquil setting.

"We are very pleased about the Department of Transportation's allocation," said High Point College President Dr. Jacob C. Martinson, who has been working behind the scenes for many months with state and city officials on the project. "We think the relocation will enable us to continue our efforts to beautify our existing campus and will make the campus a safer place for our students. From alumni groups to the National Commission on the Future of High Point College, this rerouting program has been consistently cited among our top priorities."

Martinson added that he hopes the college can turn some of the existing roadway into formal gardens.

John C. Lefler, Vice President for Institutional Advancement, sees the allocation as one of the last pieces to the puzzle. "This is an important link toward completion of the master plan of campus

development," said Lefler. "With the construction of the Athletic and Convocation Center on the north end of campus and the rerouting of Montlieu on the south end, the only remaining major project would be the development of a new Fine Arts Center. For the first time, the realization of these goals has become attainable within the foreseeable future.

"Since the day Dr. Martinson arrived on campus, he has believed in this project and portrayed it as something that would be of the ultimate benefit to the college," added Lefler. "And he has never wavered in that belief."

Many others have supported the Montlieu relocation as well. During a discussion last spring of possible road improvements that could be funded through a bond referendum, the High Point Chamber of Commerce recommended a Montlieu relocation as a top priority.

Fraternities, Sororities Find New Homes

Alumni who have returned to their alma mater this fall may have discovered a dramatic change if they ventured to one particular side of the campus.

Millis Residence Hall, which has served as a fraternity hall for many years, has been converted into a housing facility for the four campus sororities. And four houses on Montlieu Avenue and Sixth Street are being used as fraternity houses, marking the first time in school history that HPC fraternities have had their own houses.

Dottie Souder, Assistant Dean of Student Life, says "This change has been made mainly upon the fraternities' requests to be more independent. The girls in Millis shouldn't have much of a problem getting along since they had to deal with sharing space over in Yadkin Hall.

What they really needed was their own lounge and now they finally have one."

The bathrooms in Millis have also been renovated, including separate shower stalls for the girls, along with painting each sorority's colors and symbol on each floor.

"This change has been made mainly upon the Fraternities requests to be more independent."

Director of Student Activities Ronald Dalton, who lives between fraternity houses, helps the fraternities and monitors their progress. Dalton commented, "There were a lot of concerns at first (about the fraternity houses), but I think it's going extremely well."

Each house, which accommodates approximately 10 fraternity members, including officers, has an appointed house manager from the fraternity. According to Dalton, the fraternity house residents "are on their honor to obey the rules" that govern other campus residents. Dalton expressed pride in the compliance of the fraternities to the rules so far.

Al Arrigoni, president of the Inter-Fraternity Council and a resident of one of the fraternity houses, spoke to the High Point City Council and said the students want to be good neighbors and part of the city.

Fraternity members have adopted a section of Lexington Avenue for cleanup. They volunteer to work with the Father's Table and one fraternity recently conducted a Rock-A-Thon to raise money for the United Way of Greater High Point.

Roberts Hall Renovation Project Begins

Beginning in November, a complete renovation of historic Roberts Hall was launched on the High Point College campus. Roberts Hall, which was opened in 1924, is the oldest building on campus, housing administrative offices as well as classrooms and faculty offices.

Renovation plans center on returning the exterior of the building as nearly as possible to the way it originally appeared, focusing on the woodwork, tower, steeple and roof. The allocation of interior space will be redesigned as well so that the first floor of the building houses educational and classroom space, the second floor is made up of administrative offices, and the third floor includes faculty and administrative offices.

The project is expected to take 16 to 18 months to complete. The college received a \$1.8 million allocation from the College Facilities Loan Program of the United States Department of Education for the project in hopes of having the building placed on the National Register of Historic Places.

"For years, Roberts Hall has been a landmark building on campus," said John C. Lefler, Vice President for Institutional Advancement. "The building is very visible to the general public from all directions and is the most photographed building on campus. It has served in virtually every capacity, from classrooms to cafeteria, and the years of use have taken their toll. We want this building to be a reflection of the quality and standards of High Point College."

Board of Trustees Elections Held

Elections for officers and members of the High Point College Board of Trustees were held during the semi-annual meeting of the board.

Floyd T. Craven of High Point, David L. Francis of Waxhaw, Donald W. Haynes of Charlotte, and Eugene S. Littles of Charlotte have been elected as new trustees and will serve four-year terms on the board.

Craven is a partner with Bowman, Blue, Fulp and Craven Certified Public Accountants. Craven, a graduate of High

Point College, is past president of the High Point College Alumni Association.

Francis is president of Marsh Associates, Inc., in Charlotte. Francis currently serves on the Board of Directors of the Charlotte First Union National Bank, the Investors Title Company in Chapel Hill, Synco, Inc. in Charlotte, First Landmark Company in Charlotte, and is a member of the Board of Advisors, Charlotte Chamber of Commerce. Francis is a graduate of High Point College.

Haynes, a United Methodist minister, is currently director of ministries for the Western North Carolina Conference. Haynes, a graduate of High Point College, is a former chairman of the Western North Carolina Conference Board of Ordained Ministry and a member of the National Association of UMC Council Directors. He has also served as a delegate to the Southeastern Jurisdictional and General Conferences in the Church, and is a consultant to the UMC General Council on Ministries.

Littles is head coach of the Charlotte Hornets, a member of the National Basketball Association. Littles, a graduate of High Point College, remains the school's all-time leading basketball scorer and is a member of the NAIA Hall of Fame. He is also a member of the NBA Coaches Association, the North Carolina Sports Commission, and chairman of the Charlotte/Mecklenburg Project Graduation.

W. Roger Soles of Greensboro, president of Jefferson-Pilot Corporation, was re-elected chairman of the board. High Point residents George S. Erath, chairman of the board of Erath Veneer Corporation of Virginia, and S. Dave Phillips, president of Phillips Industries, were each re-elected as vice-chairmen. William V. Kester, Jr. of High Point, president of Rose Furniture Company, was elected as treasurer, while Mrs. Lois Gay of High Point, a graduate of High Point College, was re-elected as secretary.

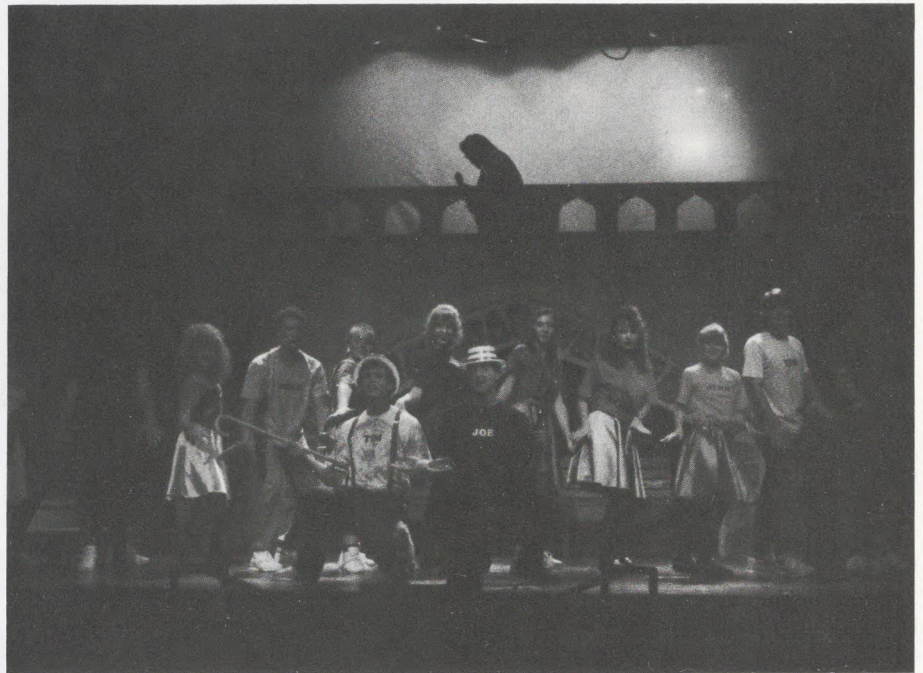
Homecoming 1990

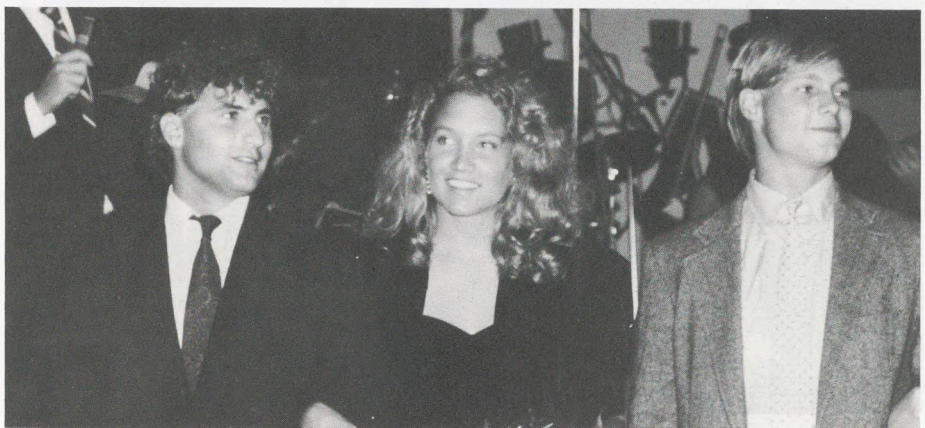

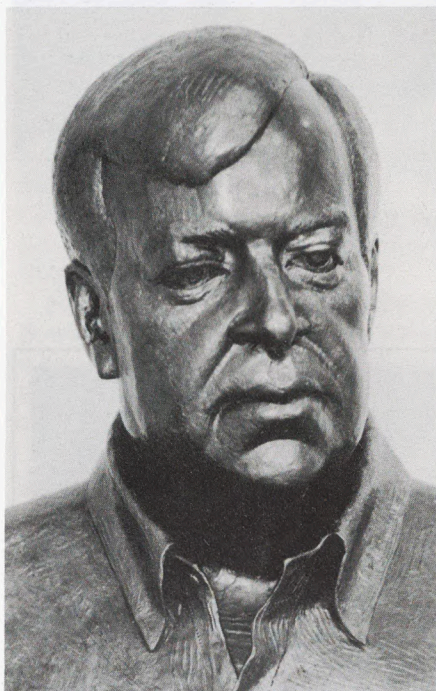

In early 1990, Andrea Dunham, Assistant Professor of Art at High Point College, was asked to participate in a portrait exhibit at the Holt McPherson Center in downtown High Point. The showing was scheduled for August and September of this year.

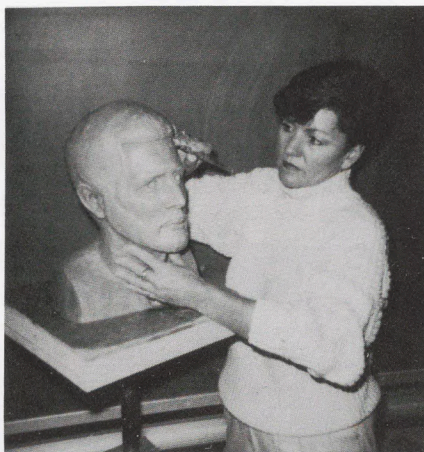
With the upcoming show in mind, she spent the summer creating a new body of

work — mainly, portrait busts of HPC faculty and staff members. These include Vice President Dr. Roy Epperson, professors Pat Haun, Dave Holt and Johnny McGee, and Athletic Director Jerry Steele.

When asked how she chose her subjects, she responded, "It all started with my father. I started working on his portrait in the HPC Sculpture Studio and

people became curious. I invited them to see the work and an idea came to me. Why not work on HPC faculty and staff? I started asking people to come in and model. Over the summer I was able to complete enough work for the exhibit."

Each sculpture took about 20 to 40 hours of work with the model and as much additional time without the model. All are made of terra-cotta fired clay,

although they look more like bronze and marble with the finishes that are applied.

When asked what she hoped to gain from the show, she said, "Every artist works with the hope of having the work seen and appreciated by people. I am interested in selling my work as well as doing portrait commissions. This exhibit was fun because some faculty and students have gotten to know me as an artist as well as a teacher. I have also gotten to know them through this process. I think it's important for the students to realize that a teacher works and produces in her field."

Ms. Dunham is also involved with the High Point Arts Council and the High Point Theater Art Galleries as the Chairman of the Exhibits Committee. She has been asked to curate two exhibits at the Theater Art Galleries in 1991 and will be donating a commissioned portrait for the Arts Council's Gala to help raise money to support the arts in High Point.

Robert P. Gruenberg

The Robert P. Gruenberg Scholarship has been established at High Point College through contributions from the college's Board of Trustees and friends of Gruenberg.

Gruenberg, former Vice President and General Manager of the Southern Furniture Market Center, died October 14, 1990 at High Point Regional Hospital. A High Point College trustee since 1979, Gruenberg had been a longtime supporter of the college, serving as chairman of the Academic Affairs Committee as well as a member of the Executive Committee. He was instrumental in the founding of the college's Home Furnishings Marketing Program in 1979. The college's Board of Trustees presented Gruenberg with a distinguished service commendation earlier in the fall.

Dr. Richard Bennington, director of the Home Furnishings Marketing Program, said, "The program is strong and vital and has had no greater supporter than Bob Gruenberg. He was a special

person, always there when we needed him."

"The board wanted to honor Bob for his distinguished service as a trustee to the college," said High Point College President Dr. Jacob C. Martinson. "He has been one of the college's greatest supporters over the years. He was a listener as well as a talker and a doer. He had the rare ability to get people to work together happily for one common objective.

Gruenberg spearheaded a fund raising drive for the establishment of scholarships for the Home Furnishings Marketing Program and was a leader of the Erath Challenge, which raised more than \$100,000 for scholarships in the program. He was also instrumental in raising more than \$250,000 for The Paul Broyhill/Home Furnishings Industry Endowed Professorship.

He founded the Home Furnishings Marketing Advisory Board at the college and served as a member of the Aspire Campaign's Steering Committee. He had

been actively involved in setting up Institutes on Management Development and Financial Management through the National Home Furnishings Association and High Point College.

Born in Brooklyn, N.Y., Gruenberg earned a master's degree from the University of Illinois before joining the National Home Furnishings Association as Executive Vice President. In 1972, he moved on to the Southern Furniture Market Center in High Point, which under his leadership, grew to the point where it became the largest concentration of home furnishings showrooms in the world.

He is survived by his wife, Imogene Chandler Gruenberg; daughter, Imogene Zimmermann of Birmingham, Mich.; sons, James C. Gruenberg of Saginaw, Mich., Peter C. Gruenberg of Winter Park, Fla.; sister, Evelyn Smith of Long Island, N.Y.; six grandchildren.

The Robert P. Gruenberg Scholarship Fund will devote income to assist students at the college through scholarship aid. First consideration will be given to students in the Home Furnishings Marketing program. Other students who possess outstanding promise and demonstrate financial need will also be considered. The first scholarship awards will be made in 1992.

"Mr. Gruenberg's memory will live in the hearts of all of us who knew him, but this named scholarship will enable future generations of students to remember him even though they didn't know him personally," said John C. Lefler, Vice President for Institutional Advancement at High Point College. "Bob was an inspiration to each of us and we believe his scholarship will provide inspiration for others."

HPC Fall Sports Enjoy Successful Seasons

Men's Cross Country — The Panthers finished third in the Carolinas Conference meet and fourth in NAIA District 26. John High, who was selected as the Conference and District Runner of the Year, was the individual champion in both meets. High qualified for the NAIA National cross country meet for the second year in a row. The senior finished in the top third at the National Meet, placing 102nd out of 385 runners.

Women's Cross Country — The Lady Panthers finished second in the Carolinas Conference and third in NAIA District 26. All-Conference performers included sophomore Cindy Harvey, junior Missy Frazier and freshman Delia Stanley, who finished fourth, fifth and sixth, respectively in the Conference meet.

Soccer — The soccer team finished the season with an 11-7-1 record and qualified for the NAIA District 26 playoffs for the 17th time in eighteen years. The Panthers got off to a 6-1 start and were ranked 10th in the NAIA national poll in late September but injuries to all three goalkeepers forced the team to use a field player in the goal. A mid-year slump was followed by a strong finish with the return of senior starter Wayne Johannessen in the goal.

High Point finished second in the regular season in the conference and lost in the semi-finals of the conference tournament. They lost to Catawba College, 2-1, in the District 26 playoffs.

Highlights of the year included wins over two nationally ranked teams, No. 9 Berry College (Ga) 2-1 in overtime and No. 12 Nova University (Fla) 3-0. The Panthers also had win over NCAA Division I opponents Appalachian State, 4-2, and Liberty University, 1-0.

Senior Thomas Ingram was named All-American for the third time while Adam Duff, a junior, was All-South. Jimmy Perrone, a senior, was All-



Conference while sophomore Marcus Cross was named All-Conference and All-District 26.

Field Hockey — The Lady Panthers posted a 10-11 record, placing third in the Deep South competition behind Davidson College and Wake Forest University. Juniors Kim Morcum, the team's leading scorer with 14 goals, and Connie Bates were selected to the All-Deep South first team and participated in the National Hockey Festival in Coca Beach, Florida.

Senior Kristen Jones was named to the second team, All-Deep South, while freshman Angie Yerkes and Catherine Hicks were third team.

Volleyball — The Lady Panthers posted an overall 20-10 record enroute to winning their 12th Carolinas Conference title in sixteen years. High Point advanced to the NAIA District 26 semi-finals, losing to Catawba College.

A trio of players were selected All-Conference led by senior Sharon Hill, the Conference and District Player of the Year. Hill was also named to the NAIA All-America team as an honorable mention selection.

Junior Renita Exhleman and sophomore Arlene King were All-Conference while King was selected All-District.

High Point College sports information director **Woody Gibson** has captured another national award for athletic yearbook design. The school's athletic yearbook took first place for best cover design this year and placed fifth nationally in the multi-sport brochure competition. The cover was designed and photographed by High Point College's Susan Lambeth of Pinnacle Studios.

Gibson handled the copy and layout of the yearbook. It's the 17th national award Gibson has garnered for the school's sports publication since 1979. The competition is sponsored by the College Sports Information Directors Association.

Football Panthers

Determining which college football team is the best in its class has not always been as difficult as it is today. Just take a look back at the 1927 High Point College Panthers.

Competing in the Little Five Conference with Atlantic Christian, Lenoir-Rhyne, Elon and Guilford, the Panthers left little doubt as to who was the No. 1 team, marching through their conference schedule without allowing a single point! The Panthers won the four games by a combined score of 94-0 to claim their first-ever conference championship.

Panther coach Jack Boylin was one of the main reasons for the team's success. A tireless recruiter, Boylin brought in players from Maryland, West Virginia, Pennsylvania, Illinois, Louisiana, Minnesota, and Wisconsin. As the school's coach in football, basketball and baseball, Boylin promised HPC President R. M. Andrews: "I'll present three sports and guarantee to win in two."

He kept his promise in a big way in 1927. The basketball team won the Little Six Conference championship as well.

Eight Panthers were selected to the 11-man Little Five Conference's **All-Zenith Football Team**. Of course, as **The Zenith** notes, the **All-Zenith** team was picked by the football squad of High Point College. Is it any wonder that sports seemed so much less complicated back then?

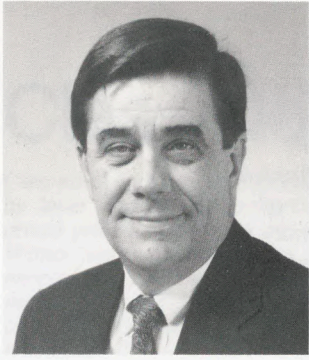
